- 17 Sec. 8222.104. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE
- 18 OR RESOLUTION. The district shall comply with all applicable
- 19 requirements of any ordinance or resolution, adopted by the
- 20 governing body of a municipality under Section 54.016, Water Code,
- 21 that consents to the creation of the district or to the inclusion of
- 22 <u>land in the district.</u>
- Sec. 8222.105. NAVIGATION DISTRICT POWERS. (a) The
- 24 district has the powers provided by the general law of this state,
- including Chapters 60 and 62, Water Code, applicable to navigation
- 26 districts created under Section 59, Article XVI, Texas
- 27 Constitution.

17	ad valorem tax, without limit as to rate or amount, for each year		
18	that all or part of the bonds are outstanding; and		
19	(2) the district annually shall impose an ad valorem		
20	tax on all taxable property in the district in an amount sufficient		
21	<u>to:</u>		
22	(A) pay the interest on the bonds or other		
23	obligations as the interest becomes due;		
24	(B) create a sinking fund for the payment of the		
25	principal of the bonds or other obligations when due or the		
26	redemption price at any earlier required redemption date; and		
27	(C) pay the expenses of imposing the taxes.

(a) The legal notice of the intention to introduce this Act, setting forth the general substance of this Act, has been published as provided by law, and the notice and a copy of this Act have been furnished to all persons, agencies, officials, or entities to which they are required to be furnished under Section 59, Article XVI, Texas Constitution, and Chapter 313, Government Code.
- 8 (b) The governor, one of the required recipients, has 9 submitted the notice and Act to the Texas Commission on 10 Environmental Quality.
- The Texas Commission on Environmental Quality has filed 11 its recommendations relating to this Act with the governor, the 12 13 lieutenant governor, and the speaker of the house of representatives within the required time. 14
- 15 (d) All requirements of the constitution and laws of this 16 state and the rules and procedures of the legislature with respect 17 to the notice, introduction, and passage of this Act are fulfilled 18 and accomplished.
- SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2007.
