5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle F, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 8216 to read as follows:
8	CHAPTER 8216. GALVESTON COUNTY MUNICIPAL UTILITY DISTRICT NO. 65
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 8216.001. DEFINITIONS. In this chapter:
11	(1) "Board" means the district's board of directors.
12	(2) "Director" means a board member.
13	(3) "District" means the Galveston County Municipal
14	Utility District No. 65.
15	Sec. 8216.002. NATURE OF DISTRICT. (a) The district is a
16	municipal utility district and a navigation district created under
17	and essential to accomplish the purposes of Section 59, Article
18	XVI, Texas Constitution.
19	(b) The district, to the extent authorized by Section
20	8216.103 and Section 52, Article III, Texas Constitution, has road
21	powers.
22	Sec. 8216.003. CONFIRMATION ELECTION REQUIRED. The board
23	shall hold an election to confirm the creation of the district as
24	provided by Section 49.102, Water Code.

Sec. 8216.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. All 1 2 land and other property in the district will benefit from the 3 improvements and services to be provided by the district. 4 Sec. 8216.005. INITIAL DISTRICT TERRITORY. (a) The district is initially composed of the territory described by 5 6 Section 2 of the Act creating this chapter. 7 (b) The boundaries and field notes contained in Section 2 of the Act creating this chapter form a closure. A mistake in the 8 9 field notes or in copying the field notes in the legislative process does not affect the district's: 10 11 (1) organization, existence, or validity; 12 (2) right to issue any type of bond for a purpose for which the district is created or to pay the principal of and 13 14 interest on the bond; 15 (3) right to impose an assessment or tax; or 16 (4) legality or operation. 17 [Sections 8216.006-8216.050 reserved for expansion] SUBCHAPTER B. 9	SUBCHAPTER C. POWERS AND DUTIES
10	Sec. 8216.101. GENERAL POWERS AND DUTIES. The district has
11	the powers and duties necessary to accomplish the purposes for
12	which the district is created.
13	Sec. 8216.102. MUNICIPAL UTILITY DISTRICT POWERS AND
14	DUTIES. The district has the powers and duties provided by the
15	general law of this state, including Chapters 49 and 54, Water Code,
16	applicable to municipal utility districts created under Section 59,
17	Article XVI, Texas Constitution.
18	Sec. 8216.103. ROAD PROJECTS. (a) Under Section 52,
19	Article III, Texas Constitution, a district may finance, construct,
20	or acquire a road project as provided by this section.
21	(b) The district shall employ, or contract with, a licensed
22	engineer to certify whether a proposed road project meets the
23	criteria for a thoroughfare, arterial, or collector road of:
24	(1) a county in whose jurisdiction the proposed road
25	project is located; or
26	(2) a municipality in whose corporate limits or
27	extraterritorial jurisdiction the proposed road project is

1 located. 2 (c) After certification by the licensed engineer, the district may finance, construct, or acquire the thoroughfare, 3 arterial, or collector road, or any improvements in aid of the road 4 5 project. 6 (d) A road project must meet all applicable standards, 7 regulations, ordinances, or orders of: 8 (1) each municipality in whose corporate limits or 9 extraterritorial jurisdiction the road project is located; and (2) each county in which the road project is located. 10 (e) The district may, with the consent of the municipality 11 12 or county, convey a completed road project to: (1) a municipality in whose corporate limits or 13 14 extraterritorial jurisdiction the road project is located; or 15 (2) a county in which the road project is located. 16 Sec. 8216.104. COMPLIANCE WITH MUNICIPAL CONSENT ORDINANCE 17 OR RESOLUTION. The district shall comply with all applicable requirements of any ordinance or resolution, adopted by the 18 governing body of a municipality under Section 54.016, Water Code, 19 that consents to the creation of the district or to the inclusion of 20 21 land in the district. Sec. 8216.105. NAVIGATION DISTRICT POWERS. (a) 22 The district has the powers provided by the general law of this state, 23 24 including Chapters 60 and 62, Water Code, applicable to navigation districts created under Section 59, Article XVI, Texas 25 26 Constitution. 27 (b) The district may purchase, construct, acquire, own,

6	SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS
7	Sec. 8216.151. ELECTIONS REGARDING TAXES OR BONDS. (a)
8	Except as provided by Subsection (c), the district may issue,
9	without an election, bonds and other obligations secured by revenue
10	or contract payments from a source other than ad valorem taxation.
11	(b) The district must hold an election in the manner
12	provided by Chapters 49 and 54, Water Code, to obtain voter approval
13	before the district may impose an ad valorem tax or issue bonds
14	payable from ad valorem taxes.
15	(c) The district may not issue bonds to finance a road
16	project unless the issuance is approved by a vote of a two-thirds
17	majority of district voters voting at an election held for that
18	purpose.
19	Sec. 8216.152. OPERATION AND MAINTENANCE TAX. (a) If
20	authorized at an election held under Section 8216.151, the district
21	may impose an operation and maintenance tax on taxable property in
22	the district as provided by Chapter 49.107, Water Code.

27	Sec. 8216.201. AUTHORITY TO ISSUE BONDS AND OTHER

S.B. No. 1997 OBLIGATIONS. The district may issue bonds or other obligations 1 2 payable wholly or partly from ad valorem taxes, impact fees, revenue, grants, or other district money, or any combination of 3 4 those sources, to pay for any authorized district purpose. Sec. 8216.202. BONDS FOR ROAD PROJECTS. At the time of 5 6 issuance, the total principal amount of a bond, note, or other 7 obligation issued or incurred to finance a road project may not exceed one-fourth of the assessed value of real property in the 8 9 district according to the most recent certified tax appraisal roll 10 for Galveston County. Sec. 8216.203. TAXES FOR BONDS AND OTHER OBLIGATIONS. At 11 the time bonds or other obligations payable wholly or partly from ad 12 valorem taxes are issued: 13 (1) the board shall impose a continuing direct annual 14 15 ad valorem tax, without limit as to rate or amount, for each year that all or part of the bonds are outstanding; and 16 17 (2) the district annually shall impose an ad valorem tax on all taxable property in the district in an amount sufficient 18 19 to: 20 (A) pay the interest on the bonds or other 21 obligations as the interest becomes due; 22 (B) create a sinking fund for the payment of the principal of the bonds or other obligations when due or the 23 24 redemption price at any earlier required redemption date; and 25 (C) pay the expenses of imposing the taxes. SECTION 2. The Galveston County Municipal Utility District 26 No. 65 initially includes all the territory contained in the 27

12 SECTION 3. (a) The legal notice of the intention to 13 introduce this Act, setting forth the general substance of this 14 Act, has been published as provided by law, and the notice and a 15 copy of this Act have been furnished to all persons, agencies, 16 officials, or entities to which they are required to be furnished 17 under Section 59, Article XVI, Texas Constitution, and Chapter 313, 18 Government Code.

(b) The governor, one of the required recipients, has
submitted the notice and Act to the Texas Commission on
Environmental Quality.

The Texas Commission on Environmental Quality has filed 22 (c) its recommendations relating to this Act with the governor, the 23 24 lieutenant governor, and the speaker of the house of representatives within the required time. 25

26 (d) All requirements of the constitution and laws of this27 state and the rules and procedures of the legislature with respect

S.B. No. 1997 to the notice, introduction, and passage of this Act are fulfilled and accomplished.

3 SECTION 4. This Act takes effect immediately if it receives 4 a vote of two-thirds of all the members elected to each house, as 5 provided by Section 39, Article III, Texas Constitution. If this 6 Act does not receive the vote necessary for immediate effect, this 7 Act takes effect September 1, 2007.
