4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. COMAL COUNTY SPECIAL IMPROVEMENT DISTRICT NO. 1.
6	Subtitle C, Title 4, Special District Local Laws Code, is amended by
7	adding Chapter 3855 to read as follows:
8	CHAPTER 3855. COMAL COUNTY SPECIAL IMPROVEMENT DISTRICT NO. 1
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 3855.001. DEFINITIONS. In this chapter:
11	(1) "Board" means the district's board of directors.
12	(2) "County" means Comal County.
13	(3) "Director" means a board member.
14	(4) "District" means the Comal County Special
15	Improvement District No. 1.
16	Sec. 3855.002. NATURE OF DISTRICT. The district is a public
17	improvement district created under and essential to accomplish the
18	purposes of Sections 52 and 52-a, Article III, and Section 59,
19	Article XVI, Texas Constitution.
20	Sec. 3855.003. COUNTY CONSENT; CONFIRMATION ELECTION
21	REQUIRED. (a) An election may not be held under this section
22	unless the commissioners court of the county adopts a resolution or
23	order consenting to the creation of the district.
24	(b) After consent by the county, the board shall hold an

election to confirm the creation of the district as provided by 1 2 Section 49.102, Water Code. Sec. 3855.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. All 3 4 land and other property in the district will benefit from the 5 improvements and services to be provided by the district. 6 Sec. 3855.005. INITIAL DISTRICT TERRITORY. (a) The 7 district is initially composed of the territory described by 8 Section 2 of the Act creating this chapter. (b) The boundaries and field notes contained in Section 2 of 9 the Act creating this chapter form a closure. A mistake in the 10 field notes or in copying the field notes in the legislative process 11 12 does not affect the district's: (1) organization, existence, or validity; 13 14 (2) right to issue any type of bond for a purpose for 15 which the district is created or to pay the principal of and interest on the bond; 16 17 (3) right to impose an assessment or tax; or (4) legality or operation. 18 Sec. 3855.006. APPLICABILITY OF PUBLIC IMPROVEMENT 19 DISTRICTS LAW. Except as otherwise provided by this chapter, 20 21 Subchapter C, Chapter 372, Local Government Code, applies to the 22 district. 23 [Sections 3855.007-3855.050 reserved for expansion] 24 SUBCHAPTER B. BOARD OF DIRECTORS 25 Sec. 3855.051. GOVERNING BODY; TERMS. (a) The district is 26 governed by a board of seven directors appointed by the 27 commissioners court of the county.

2	four directors' terms expiring June 1 of each year.

4	SUBCHAPTER C. POWERS AND DUTIES
5	Sec. 3855.101. PUBLIC IMPROVEMENT DISTRICT POWERS AND
6	DUTIES. The district has the powers and duties applicable to public
7	improvement districts created under Subchapter C, Chapter 372,
8	Local Government Code, including the power to:
9	(1) impose an assessment, ad valorem tax, sales and
10	use tax, or hotel occupancy tax;
11	(2) issue bonds payable from any source of district
12	money; and
13	(3) make an economic development grant or loan.
14	Sec. 3855.102. NO EMINENT DOMAIN POWER. The district may
15	not exercise the power of eminent domain.
16	[Sections 3855.103-3855.150 reserved for expansion]
17	SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS
18	Sec. 3855.151. GENERAL AUTHORITY TO USE DISTRICT MONEY FOR
19	DISTRICT PURPOSES. Using any money available to the district, the
20	district may accomplish any district purpose or pay the cost of any
21	service or improvement.
22	Sec. 3855.152. AUTHORITY TO IMPOSE ASSESSMENTS AND TAXES.
23	To accomplish any district purpose, the district may impose:
24	(1) an assessment;
25	(2) an ad valorem tax;
26	(3) a sales and use tax; or
27	(4) a hotel occupancy tax.

1	Sec. 3855.153. TAX AND BOND ELECTIONS REQUIRED. (a) The
2	district may not issue bonds or impose an ad valorem tax, sales and
3	use tax, or hotel occupancy tax unless the issuance or the tax is
4	approved by a majority of the district voters voting at an election
5	held for that purpose.
6	(b) The district shall hold the election in the manner
7	provided by Subchapter L, Chapter 375, Local Government Code.
8	(c) Section 375.243, Local Government Code, does not apply
9	to the district.
10	Sec. 3855.154. COUNTY AUTHORITY. An assessment, ad valorem
11	tax, sales and use tax, or hotel occupancy tax imposed under this
12	chapter is subject to any applicable approvals or rates set by the
13	county under Subchapter C, Chapter 372, Local Government Code.
14	[Sections 3855.155-3855.200 reserved for expansion]
15	SUBCHAPTER E. BONDS
16	Sec. 3855.201. AUTHORITY TO ISSUE BONDS AND OTHER
17	OBLIGATIONS. (a) The district may issue bonds or other obligations
18	payable wholly or partly from assessments, ad valorem taxes, sales
19	and use taxes, hotel occupancy taxes, fees, revenue, grants, or
20	other district money, or any combination of those sources, to pay
21	for any authorized district purpose.
22	(b) In addition to any other terms authorized by the board
23	by bond order or resolution, the proceeds of the district's bonds
24	may be used for a reserve fund, credit enhancement, or capitalized
25	interest for the bonds.
26	Sec. 3855.202. TAXES FOR BONDS AND OTHER OBLIGATIONS. At
27	the time bonds or other obligations payable wholly or partly from ad

1	valorem taxes are issued:
2	(1) the board shall impose a continuing direct annual
3	ad valorem tax, without limit as to rate or amount, for each year
4	that all or part of the bonds are outstanding; and
5	(2) the district annually shall impose an ad valorem
6	tax on all taxable property in the district in an amount sufficient
7	<u>to:</u>
8	(A) pay the interest on the bonds or other
9	obligations as the interest becomes due;
10	(B) create a sinking fund for the payment of the
11	principal of the bonds or other obligations when due or the
12	redemption price at any earlier required redemption date; and
13	(C) pay the expenses of imposing the taxes.

SECTION 3. LEGISLATIVE FINDINGS. The legislature finds

13 that:

(1) proper and legal notice of the intention to 14 15 introduce this Act, setting forth the general substance of this Act, has been published as provided by law, and the notice and a 16 copy of this Act have been furnished to all persons, agencies, 17 officials, or entities to which they are required to be furnished by 18 the constitution and laws of this state, including the governor, 19 20 who has submitted the notice and Act to the Texas Commission on Environmental Quality; 21

(2) the Texas Commission on Environmental Quality has
filed its recommendations relating to this Act with the governor,
lieutenant governor, and speaker of the house of representatives
within the required time;

(3) the general law relating to consent by politicalsubdivisions to the creation of districts with conservation,

S.B. No. 2008 1 reclamation, and road powers and the inclusion of land in those 2 districts has been complied with; and

3 (4) all requirements of the constitution and laws of 4 this state and the rules and procedures of the legislature with 5 respect to the notice, introduction, and passage of this Act have 6 been fulfilled and accomplished.

7 SECTION 4. EFFECTIVE DATE. This Act takes effect 8 immediately if it receives a vote of two-thirds of all the members 9 elected to each house, as provided by Section 39, Article III, Texas 10 Constitution. If this Act does not receive the vote necessary for 11 immediate effect, this Act takes effect September 1, 2007.
