15	Sec. 30.01902. JUDGE. Sections 30.00007(b)(1), (2), (3),	
16	and (5) do not apply to this subchapter.	
17	Sec. 30.01903. MUNICIPAL COURT DIRECTOR; OTHER PERSONNEL.	
18	(a) The city manager shall appoint a municipal court director to	
19	serve as the clerk of the municipal courts of record.	
20	(b) The municipal court director shall perform, as	
21	applicable, the duties prescribed by law for the county clerk of a	
22	county court at law. In addition, the municipal court director	
23	shall:

(1) maintain central docket records for all cases

- filed in the municipal courts of record;
- 2 (2) maintain an index of all municipal court of record
- 3 judgments in the same manner as county clerks are required by law to
- 4 prepare for criminal cases arising in county courts; and
- 5 (3) request the jurors needed for cases that are set
- 6 for trial by jury.
- 7 (c) The municipal court director may hire, direct, and
- 8 remove the personnel authorized in the city's annual budget for the
- 9 clerk's office.
- 10 (d) Sections 30.00009(c) and (d) do not apply to this
- 11 subchapter.
- 12 Sec. 30.01904. COURT REPORTER. The municipal court
- director shall appoint the court reporter under Section 30.00010.
- 14 SECTION 2. This Act takes effect immediately if it receives
- a vote of two-thirds of all the members elected to each house, as
- 16 provided by Section 39, Article III, Texas Constitution. If this
- 17 Act does not receive the vote necessary for immediate effect, this
- 18 Act takes effect September 1, 2007.
