1-8 A BILL TO BE ENTITLED
1-9 AN ACT

1-10 relating to the boundaries and board of directors of Harris County
1-11 Improvement District No. 6.

1-12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-13 SECTION 1. Subsection (a), Section 3843.051, Special
1-14 District Local Laws Code, is amended to read as follows:

1-15 (a) The district is governed by a board of 13 [~~11~~] directors
1-16 who serve staggered terms of four years with six [~~five~~] or seven
1-17 [~~six~~] directors' terms expiring June 1 of each odd-numbered year.

1-18 SECTION 2. Section 3843.053, Special District Local Laws
1-19 Code, is amended to read as follows:

1-20 Sec. 3843.053. BOARD [~~INITIAL DIRECTORS~~]. (a) The

1-37 appointed for positions 1 through 6 expire June 1, 2011 [~~2009~~], and
1-38 the terms of directors appointed for positions 7 through 13 [~~11~~]
1-39 expire June 1, 2009 [~~2007~~].

1-40 (b-1) The term of each membership position on the board as
1-41 the term exists immediately preceding the effective date of the Act
1-42 adding this subsection expires on that effective date. On that
1-43 date, a new board is appointed as provided by Subsection (a) to
1-44 serve terms as provided by Subsection (b).

1-45 (c) Section 3843.051 does not apply to this section.

1-46 (d) This section expires September 1, 2011 [~~2009~~].

1-47 SECTION 3. Section 2, Chapter 769, Acts of the 79th
1-48 Legislature, Regular Session, 2005, is amended to read as follows:

1-49 Sec. 2. BOUNDARIES. The [~~As of the effective date of this~~
1-50 ~~Act, the~~] Harris County Improvement District No. 6 includes all
1-51 territory contained in the following described area:

 2-16 Thence southwesterly along the center right of way line of Milam
 2-17 Street to its intersection with the center right of way line of Spur
 2-18 527;
 2-19 Thence southerly following southwesterly along the center right of
 2-20 way line of Spur 527 to its intersection with the center right of
 2-21 way line of US 59 South;
 2-22 Thence easterly along the center right of way of US 59 South to its
 2-23 intersection with the center right of way line of Main;
 2-24 Thence southwesterly along the center right of way line of Main to
 2-25 the north property line of Block 1, South End Villa according to the
 2-26 map thereof recorded in Volume 1, Page 104 of the Harris County Map
 2-27 Records;
 2-28 Thence westerly along the north property line of said Block 1, South
 2-29 End Villa and the south property line of the C.C. Fitze Homestead
 2-30 Addition according to the plat thereof recorded in Volume 259, Page
 2-31 163 of the Harris County Deed Records, crossing the north dead end
 2-32 of Travis to the center right of way line thereof;
 2-33 Thence southwesterly along the center right of way line of Travis to
 2-34 the center right of way line of Portland;
 2-35 Thence easterly along the center right of way line of Portland to
 2-36 the the center right of way line of Main;
 2-37 Thence southwesterly along the center right of way line of Main to
 2-38 its intersection with the center right of way line of Bissonnet;
 2-39 Thence westerly along the center right of way line of Bissonnet to
 2-40 its intersection with the center right of way line of Graustark;
 2-41 Thence northerly along the center right of way line of Graustark to
 2-42 its intersection with the center right of way line of US 59 South;
 2-43 Thence westerly along the center right of way line of US 59 South to
 2-44 its intersection with the east right of way line of South Shepherd
 2-45 Drive;
 2-46 Thence northerly along the east right of way line of South Shepherd
 2-47 Drive following along the northeast right of way line of Shepherd
 2-48 Drive to its intersection with the center right of way line West
 2-49 Dallas Avenue;
 2-50 Thence easterly along the center right of way line of West Dallas to

SECTION 4. The legislature finds that:

3-33 (1) proper and legal notice of the intention to
3-34 introduce this Act, setting forth the general substance of this
3-35 Act, has been published as provided by law, and the notice and a
3-36 copy of this Act have been furnished to all persons, agencies,
3-37 officials, or entities to which they are required to be furnished by
3-38 the constitution and laws of this state, including the governor,
3-39 who has submitted the notice and Act to the Texas Commission on
3-40 Environmental Quality;

3-41 (2) the Texas Commission on Environmental Quality has
3-42 filed its recommendations relating to this Act with the governor,
3-43 lieutenant governor, and speaker of the house of representatives
3-44 within the required time;

3-45 (3) the general law relating to consent by political
3-46 subdivisions to the creation of districts with conservation,
3-47 reclamation, and road powers and the inclusion of land in those
3-48 districts has been complied with; and

3-49 (4) all requirements of the constitution and laws of
3-50 this state and the rules and procedures of the legislature with
3-51 respect to the notice, introduction, and passage of this Act have
3-52 been fulfilled and accomplished.

3-53 SECTION 5. This Act takes effect immediately if it receives
3-54 a vote of two-thirds of all the members elected to each house, as
3-55 provided by Section 39, Article III, Texas Constitution. If this
3-56 Act does not receive the vote necessary for immediate effect, this
3-57 Act takes effect September 1, 2007.
