SENATE RESOLUTION

1-7 WHEREAS, From 1945 to 1991, the world witnessed a military, 1-8 economic, and ideological confrontation known as the Cold War; 1-9 waged most prominently by the United States and the Soviet Union, 1-10 the struggle involved almost every nation on earth to some degree 1-11 and had a profound impact on the course of world history over the 1-12 latter half of the 20th century; and

latter half of the 20th century; and WHEREAS, Although the Cold War never erupted into a full-scale armed conflict between the world's superpowers, it gave impetus to a number of localized hot wars, as well as to a massive,

1-15 impetus to a number of localized hot wars, as well as to a massive, 1-16 long-term arms race; and 1-17 WHEREAS, Throughout the Cold War, the State of Texas played a 1-18 significant role in this country's military preparedness by 1-19 contributing personnel to the armed forces, serving as the site of 1-20 important military facilities, and providing material support by 1-21 way of private industry; and

1-22 WHEREAS, Tens of thousands of Texans served in the military
1-23 during the course of the Cold War, and many made the ultimate
1-24 sacrifice; the loss of Texans in Korea from 1950 to 1957 numbered
1-25 1,719, and in Vietnam, 3,415; and

1-26 WHEREAS, The state currently has 16 military installations 1-27 that figured notably in the country's defense system during the 1-28 period of the Cold War; moreover, Texas was home to Nike and Atlas 1-29 Ballistic Missile silos, as well as to Strategic Air Command units at Biggs, Carswell, Sheppard, Dyess, Amarillo, and Bergstrom Air Force Bases; other air force bases located in the state during that 1-30 1-31 1-32 included Brooks, Goodfellow, Kelly, Lackland, time Laredo, 1-33

1-33 Laughlin, Randolph, Reese, and Webb; and
1-34 WHEREAS, All 15 of those air force facilities constituted
1-35 first-strike targets for the Soviet military; secondary targets in
1-36 Texas included Beeville, Corpus Christi, Kingsville,
1-37 Sherman-Denison, Texarkana, Fort Bliss, Fort Hood, and the Houston
1-38 petrochemical complex; and

1-39 WHEREAS, Many industrial enterprises in Texas made vital 1-40 contributions during the Cold War years; the state's oil industry 1-41 had a major role in supplying the Strategic Petroleum Reserve, 1-42 while a number of key defense contractors were either based in Texas 1-43 or had large Texas operations; among such companies were Texas 1-44 Instruments, Lockheed, EDS, Bell Helicopter, and Textron; and

1-45 WHEREAS, One dimension of the Cold War involved a race for 1-46 leadership in space exploration; crucial to American efforts in 1-47 this arena was the Johnson Space Center in Houston, the National 1-48 Aeronautics and Space Administration headquarters for manned 1-49 spaceflight; and

1-50 WHÉREAS, Eight successive American presidents grappled with 1-51 the challenges of the Cold War; two of these--Dwight D. Eisenhower 1-52 and Lyndon B. Johnson--were born in Texas and led the nation during 1-53 the Korean War and Vietnam War, respectively; and

1-54 WHEREAS, Military veterans of the Cold War have continued to 1-55 contribute to this country as private citizens and as public 1-56 servants; a number of them have been elected to leadership posts at 1-57 both the state and national levels; and

1-58 WHEREAS, It is essential that the history of the Cold War 1-59 decades be preserved, for the events of that time touched the lives 1-60 of millions of people and helped to set the stage for the 21st 1-61 century; in reflecting on that long and difficult confrontation, it 1-62 is also fitting that tribute be paid to the men and women of the 1-63 United States armed forces, who served selflessly and heroically in 1-64 that epic struggle; now, therefore, be it S.R. No. 941 2-1 RESOLVED, That the Senate of the State of Texas, 80th 2-2 Legislature, hereby recognize May 1, 2007, as Cold War Victory Day 2-3 and extend to all Cold War veterans of the American military sincere 2-4 appreciation for their exemplary service; and, be it further 2-5 RESOLVED, That a copy of this Resolution be prepared in honor 2-6 of Cold War veterans.
