- 4 (2) Senate Rule 12.03(1) is suspended to permit the
- 5 committee to change the text of the SECTION of the bill that is
- 6 renumbered in the conference committee report as SECTION 6 to read
- 7 as follows:
- 8 SECTION 6. The changes in law made by Sections 1, 2, 3, and 4
- 9 of this Act apply only to the estate of a decedent who dies on or
- 10 after the effective date of this Act. The estate of a decedent who
- 11 dies before the effective date of this Act is governed by the law in
- 12 effect on the date of the decedent's death, and the former law is
- 13 continued in effect for that purpose.
- 14 Explanation: The change to the applicability provision of
