10	(1) current wages for personal services, except for
11	the enforcement of court-ordered child support payments;
12	(2) professionally prescribed health aids of a debtor
13	or a dependent of a debtor; [and]
14	(3) alimony, support, or separate maintenance
15	received or to be received by the debtor for the support of the
16	debtor or a dependent of the debtor; and
17	(4) a religious bible or other book containing sacred
18	writings of a religion.
19	(c) Except as provided by Subsection (b)(4), this [This]
20	section does not prevent seizure by a secured creditor with a
21	contractual landlord's lien or other security in the property to be
22	seized.
23	SECTION 2. The changes in law made by this Act do not apply

- to a voluntary bankruptcy proceeding or to valid claims of a holder
- 2 of a final judgment who has, by levy or other legal process,
- 3 obtained rights superior to those that would otherwise be held by a
- 4 trustee in bankruptcy if a bankruptcy petition were then pending
- 5 against the debtor. That property is subject to the law as it
- 6 existed immediately before the effective date of this Act, and the
- 7 prior law is continued in effect for that purpose.
