RESOLUTION

1 WHEREAS, The passing of former state representative Leopoldo 2 "Leo" Alvarado, Jr., on June 5, 2009, at the age of 70, has 3 profoundly saddened the legal and legislative communities and 4 citizens throughout San Antonio and brought a great loss to his 5 family and friends; and

6 WHEREAS, Born in San Antonio on April 23, 1939, Leo Alvarado was the son of Maria del Refugio Farias de Alvarado and Leopoldo 7 Alvarado, Sr.; he grew up on the West Side and graduated from 8 Jefferson High School before enlisting in the United States Air 9 Force; following his service to his country, he enrolled in 10 11 St. Mary's University, where he earned his bachelor's degree in 12 political science and accounting and went on to receive his law degree in 1974; and 13

14 WHEREAS, This dedicated community activist helped organize the J.F.K. Community Forum, which laid the groundwork for West San 15 16 Antonio agencies engaged in the war on poverty, and served as a consultant to the Inner City Apostolate and as a director of the 17 Mexican American Unity Council and of Project Health and Viable 18 Economics; he was vice chair of the board of the Bexar County 19 20 Hospital District and worked toward the purchase and reopening of 21 Lutheran General Hospital to serve downtown residents; and

WHEREAS, Highly respected in his legal career, Mr. Alvarado handled many complex injury and public interest cases; he played an important role in landmark *Edgewood ISD* cases involving the

1 redistribution of funds from wealthy to poorer school districts,
2 which ultimately led to increased support for education in lower
3 income communities; he was a partner in Weir & Alvarado, P.C.,
4 before forming Alvarado & Alvarado, P.L.L.C., with his daughter,
5 Rosemarie Alvarado-Hawkins; and

WHEREAS, Mr. Alvarado was first elected to the Texas House of 6 Representatives in 1992 and served the people of District 116 for 7 8 eight years; during his tenure, he was chair of the Freshman House Caucus and was a valued member of the civil practices, house 9 10 administration, state affairs, redistricting, insurance, and judicial affairs committees; a man of principle and integrity, he 11 12 worked to improve the lives of all Texans, and he introduced bills 13 relating to high school education and redlining in the insurance 14 industries, among numerous others; and

15 WHEREAS, A devoted and loving father, Mr. Alvarado most 16 enjoyed spending time with his family, whom he placed first in all 17 matters; he was also fond of hunting, fishing, playing guitar, 18 cooking, painting, gardening, and travel; and

WHEREAS, Leo Alvarado leaves a legacy of accomplishments that will continue to benefit people in this state for years to come, and he will long be remembered with deep affection and admiration by all who were fortunate enough to share in the richness of his life; now, therefore, be it

RESOLVED, That the House of Representatives of the 81st Texas Legislature, 1st Called Session, 2009, hereby pay tribute to the memory of Leopoldo "Leo" Alvarado, Jr., and extend sincere sympathy to the members of his family: to his brother, Carlos Alvarado; to
