## RESOLUTION

1 WHEREAS, Albert Hawkins is retiring as 2 commissioner of the Texas Health and Human Services Commission on August 31, 2009, and it is most fitting to recognize him for his 3 outstanding leadership as his tenure draws to a close; and 4 5 WHEREAS, Appointed by Governor Rick Perry in January 2003, Mr. Hawkins directs the operations of five health and human 6 services agencies with more than 50,000 employees and a combined 7 budget of about \$55 billion; during his tenure, he oversaw the 8 consolidation of 12 agencies into five and he initiated substantial 9 enhancements in child and adult protective services; widely 10 11 recognized as a budget expert, he instituted administrative changes 12 in the Texas Medicaid program that have saved millions of dollars, as well as innovations that include personalized treatment plans 13 14 for clients with chronic health issues and electronic health passports for children from foster homes; and 15 WHEREAS, Mr. Hawkins met the challenges of natural disasters 16 with compassion and efficiency; by ensuring the availability of 17 federal resources, he avoided overburdening Texas taxpayers while 18 providing timely aid to victims of Hurricanes Katrina, Rita, and 19 Ike; during his tenure, HHSC won increased federal funding for 20 21 services, more than doubling Upper Payment Limits for doctors and hospitals and significantly increasing funding for services to the 22 23 deaf and hearing impaired; moreover, Mr. Hawkins worked with the legislature to expand community placement options to serve an 24

- 1 additional 20,000 clients with disabilities and special health care

- 3 WHEREAS, A Fort Worth native, Mr. Hawkins worked his way
- 4 through The University of Texas at Austin as a postal service
- 5 employee and earned his master's degree in public affairs from the
- 6 Lyndon B. Johnson School of Public Affairs; he joined the Texas
- 7 Legislative Budget Board in 1978 as a program analyst and
- 8 eventually became deputy director of the agency; from 1995 to 2000,
- 9 he served as budget director for Governor George W. Bush, and he
- 10 went on to serve on the senior staff in the Bush White House as
- 11 assistant to the president and secretary to the cabinet; and
- 12 WHEREAS, This dynamic 35-year veteran of government service
- 13 has received numerous accolades, including the Whitney M. Young
- 14 Award of the Austin Urban League, the Outstanding Leadership Award
- 15 of the Austin Chapter of Blacks in Government, and the Bob Bullock
- 16 Award for Outstanding Public Stewardship; he received an honorary
- 17 doctorate in public service from the University of North Texas
- 18 Health Science Center and was named a distinguished alumnus by the
- 19 LBJ School; in addition, he was named Texas State Administrator of
- 20 the Year for 1998; he has served his local community as chair of the
- 21 Austin Area Urban League, as board treasurer of the Capital Area
- 22 United Way, as a mentor and board member of Project M.A.N., Inc.,
- 23 and as a member of the board of Big Brothers/Big Sisters of Austin;

- 25 WHEREAS, Highly respected for his integrity, dedication, and
- 26 uncompromising commitment to excellence and fiscal responsibility,
- 27 Albert Hawkins skillfully guided the Health and Human Services
