## RESOLUTION

1 WHEREAS, Jimmie Hall Kester, a respected expert in the field 2 of juvenile justice and a cherished friend to many, passed away on 3 June 18, 2009, at the age of 72; and

WHEREAS, The son of Velman "Jack" and Sallie Kester, Jim 4 Kester was born on August 31, 1936, in Reed, Oklahoma, and spent his 5 early years on a cotton farm; his family later moved throughout the 6 7 southwestern United States, where he enjoyed an adventurous childhood along with his older brother, Jack; at the age of 18, Mr. 8 Kester joined the U.S. Navy, and while he was in college, he 9 continued his service as a member of the Naval Reserve; he went on 10 11 to earn bachelor's and master's degrees in education from the University of Oklahoma and a master's degree in social service 12 administration from the University of Chicago, and he also pursued 13 doctoral studies in philosophy; and 14

WHEREAS, After working as a public school teacher and a 15 16 social worker in New York City's Hell's Kitchen neighborhood in the 1960s, Mr. Kester focused his career on helping at-risk youth; he 17 served as director of the Oklahoma Council on Crime and Delinquency 18 before accepting a position in the Criminal Justice Division of the 19 Texas Governor's Office in 1975; there he introduced innovative 20 programs and improved services for at-risk youth, and his ability 21 to foster positive working relationships with others made him a 22 23 valued public servant over the course of three decades and five different gubernatorial administrations; on his retirement, he 24

1 remained a tireless advocate for troubled young people as a member 2 of the Governor's Juvenile Justice Advisory Board and as a board 3 member of the Council on At-Risk Youth; and

WHEREAS, Mr. Kester further contributed to his community as a mentor to Austin public school students and as a member of the American Legion, Travis Post 76; moreover, he taught Sunday school and participated in such church programs as the Stephen Ministry and Emmaus; in his leisure time, he took pleasure in studying naval history and in tending to his property in the Texas Hill Country, which he affectionately called "The Land"; and

11 WHEREAS, Jim Kester was an inspiring role model to friends, 12 family, and colleagues alike, who were drawn to his kind and 13 generous nature, as well as to his gift for finding meaning in the 14 everyday; although he will be deeply missed by all those who were 15 privileged to know him, he leaves behind a legacy that will continue 16 to resonate for years to come; now, therefore, be it
