| 16 | SECTION 2. Subchapter B, Chapter 402, Government Code, is |

- (1) make grants to an eligible organization; and
- 5 (2) defray the cost of administering the account.
- 6 (c) The attorney general may not discriminate against an
 7 eligible organization because it is a religious or nonreligious
 8 organization.
- 9 <u>(d) The attorney general may accept gifts, donations, and</u> 10 grants from any source for the benefit of the account.
- 11 (e) The attorney general by rule shall establish:
- 12 <u>(1) guidelines for the expenditure of money credited</u>
 13 to the Choose Life account; and
- 14 (2) reporting and other mechanisms necessary to ensure
 15 that the money is spent in accordance with this section.
 - (f) Of any money received by an eligible organization under this section, at least 50 percent must be spent to provide for the material needs of pregnant women who are considering placing their children for adoption, including the provision of clothing, housing, prenatal care, food, utilities, and transportation, and to provide for the needs of infants who are awaiting placement with adoptive parents. The remainder may be used to provide counseling, training, advertising, and pregnancy testing, but may not be used

- 11 (6) does not contract with an organization that
- 12 provides abortions or abortion-related services or makes referrals
- 13 to abortion providers.
- 14 Sec. 402.036. CHOOSE LIFE ADVISORY COMMITTEE. (a) The
- attorney general shall appoint a seven-member Choose Life advisory
- 16 committee.
- 17 (b) The committee shall:
- 18 (1) meet at least twice a year or as called by the
- 19 attorney general;
- 20 (2) assist the attorney general in developing rules
- 21 under Section 402.035(e); and
- 22 (3) review and make recommendations to the attorney
- 23 general on applications submitted to the attorney general for
- 24 grants funded with money credited to the Choose Life account.
- 25 (c) Members of the committee serve without compensation and
- 26 <u>are not entitled to reimbursement for expenses. Each member serves</u>
- 27 a term of four years, with the terms of three or four members
