1-6 A BILL TO BE ENTITLED
1-7 AN ACT

1-8 relating to the grounds for removal of a member of the board of
1-9 directors of the Lynn County Hospital District.

1-10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-11 SECTION 1. Section 4A(a), Chapter 66, Acts of the 60th
1-12 Legislature, Regular Session, 1967, is amended to read as follows:

1-13 (a) It is a ground for removal from the board of directors
1-14 that a member:

1-15 (1) is absent from more than half [~~three-fourths~~] of
1-16 the regularly scheduled board meetings that the member is eligible
1-17 to attend during a calendar year without an excuse approved by a
1-18 majority vote of the board; or

1-19 (2) fails to timely pay a federal, state, or local tax,
1-20 including an ad valorem tax.

1-21 SECTION 2. Section 1054.0565(a), Special District Local
1-22 Laws Code, as effective September 1, 2009, is amended to read as
1-23 follows:

1-24 (a) It is a ground for removal from the board that a
1-25 director:

1-26 (1) is absent from more than half [~~three-fourths~~] of
1-27 the regularly scheduled board meetings that the director is
1-28 eligible to attend during a calendar year without an excuse
1-29 approved by a majority vote of the board; or

1-30 (2) fails to timely pay a federal, state, or local tax,
1-31 including an ad valorem tax.

1-32 SECTION 3. (a) Section 1 of this Act takes effect only if
1-33 the Act of the 81st Legislature, Regular Session, 2009, relating to
1-34 nonsubstantive additions to and corrections in existing codes does
1-35 not become law. If the Act of the 81st Legislature, Regular
1-36 Session, 2009, relating to nonsubstantive additions to and
1-37 corrections in existing codes becomes law, Section 1 of this Act has
1-38 no effect.

1-39 (b) Section 2 of this Act takes effect only if the Act of the
1-40 81st Legislature, Regular Session, 2009, relating to
1-41 nonsubstantive additions to and corrections in existing codes
1-42 becomes law. If the Act of the 81st Legislature, Regular Session,
1-43 2009, relating to nonsubstantive additions to and corrections in
1-44 existing codes does not become law, Section 2 of this Act has no
1-45 effect.

1-46 SECTION 4. This Act takes effect September 1, 2009.
