(a) The comptroller shall include the 8 9 following statement on each application for a permit or license issued by the comptroller: 10 WARNING. You may be required to obtain an additional permit 11 12 or license from the State of Texas or from a local governmental entity to conduct business. A listing of links relating to 13 14 acquiring licenses, permits, and registrations from the State of av<u>ailable</u> is 15 online 16 http://www.TexasOnline.com/portal/tol/en/9/1. You may also want to contact the municipality and county in which you will conduct 17 business to determine any local governmental requirements. 18 (b) The statement required by Subsection (a) must be placed 19 in the applicant signature box or, if the application does not have 20 21 an applicant signature box, on the last line above the applicant signature line, and in bold typeface that is at least as large as 22 23 any other typeface appearing in the general instructions relating to the application. 24

- 4 SECTION 2. Not later than the 60th day after the effective
- 5 date of this Act, the comptroller of public accounts shall modify
- 6 each application for a permit or license issued by the comptroller
- 7 as necessary to comply with Section 111.00457, Tax Code, as added by
- 8 this Act.
- 9 SECTION 3. This Act takes effect immediately if it receives
- 10 a vote of two-thirds of all the members elected to each house, as
- 11 provided by Section 39, Article III, Texas Constitution. If this
- 12 Act does not receive the vote necessary for immediate effect, this
- 13 Act takes effect September 1, 2009.
