(D) a community health center as defined by
 Section 136.002, Human Resources Code.

3 (c) A dental hygienist may <u>only</u> [not] perform [a second set
4 of] delegated tasks or procedures with respect to a patient for one
5 <u>year unless</u> [until] the patient has been examined by a dentist in
6 compliance with Section 262.151(a)(2).

7 (e) The [nursing] facility or program under Subsection
8 (a)(2) [school-based health center] shall note each delegated
9 service, task, or procedure performed by the dental hygienist under
10 this section in the patient's medical records.

SECTION 3. Section 262.152, Occupations Code, is amended to read as follows:

Sec. 262.152. PERFORMANCE OF DELEGATED DUTIES. <u>Except as</u> <u>provided by Section 262.1515, a</u> [A] dental hygienist shall practice dental hygiene:

16 (1) in the dental office of a supervising dentist 17 licensed by the board; or

18 (2) in an alternate setting, including a nursing home,
19 the patient's home, a school, a hospital, a state institution, a
20 public health clinic, or another institution, under the supervision
21 of a supervising dentist.
