A BILL TO BE ENTITLED

- 1 AN ACT
- 2 relating to the sale of fireworks on and before Texas Independence
- 3 Day.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 2154.202(g), Occupations Code, is
- 6 amended to read as follows:
- 7 (g) A retail fireworks permit holder may sell fireworks only
- 8 to the public, and only during periods:
- 9 (1) beginning February 20 and ending at midnight on
- 10 March 2;
- 11 (2) beginning June 24 and ending at midnight on July 4;
- 12 $\underline{(3)}$ [$\underline{(2)}$] beginning December 20 and ending at midnight
- 13 on January 1 of the following year; and
- 14 (4) $[\frac{(3)}{(3)}]$ beginning May 1 and ending at midnight on
- 15 May 5 if the fireworks are sold at a location that is not more than
- 16 100 miles from the Texas-Mexico border and that is in a county in
- 17 which the commissioners court of the county has approved the sale of
- 18 fireworks during the period.
- 19 SECTION 2. Section 352.051(b)(1), Local Government Code, is
- 20 amended to read as follows:
- 21 (b)(1) The Texas Forest Service in the ordinary course of
- 22 its activities shall determine whether drought conditions, as
- 23 defined under Subsection (a)(2), exist on average in any county
- 24 requesting such a determination. The Texas Forest Service shall

- 1 make available the measurement index guidelines used to determine
- 2 whether drought conditions exist in a particular area. Following
- 3 any determination that such drought conditions exist, the Texas
- 4 Forest Service shall notify said county or counties when such
- 5 drought conditions no longer exist. The Texas Forest Service shall
- 6 make its services available each day during the <u>Texas Independence</u>
- 7 Day, Fourth of July, and December fireworks seasons to respond to
- 8 the request of any county for a determination whether drought
- 9 conditions exist on average in the county.
- SECTION 3. Section 352.051(d), Local Government Code, is
- 11 amended to read as follows:
- 12 (d) To facilitate compliance with an order adopted under
- 13 Subsection (c), the order must be adopted before:
- 14 (1) February 15 of each year for the Texas
- 15 Independence Day fireworks season;
- 16 <u>(2)</u> April 25 of each year for the Cinco de Mayo
- 17 fireworks season;
- 18 (3) $\left[\frac{(2)}{2}\right]$ June 15 of each year for the Fourth of July
- 19 fireworks season; and
- 20 $\underline{(4)}$ [$\underline{(3)}$] December 15 of each year for each December
- 21 fireworks season.
- 22 SECTION 4. This Act takes effect September 1, 2009.
