7	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
8	SECTION 1. Subchapter B, Chapter 7, Education Code, is
9	amended by adding Section 7.031 to read as follows:
10	Sec. 7.031. GRANTS. (a) The agency may seek, accept, and
11	distribute grants awarded by the federal government or any other
12	public or private entity for the benefit of public education,
13	subject to the limitations or conditions imposed by the terms of the
14	grants or by other law.
15	(b) Unless otherwise prohibited by federal law, the
16	commissioner may determine, solely for purposes of the program's
17	eligibility to receive federal grant funds, for the purpose of
18	technology services and support, that a Head Start program operated
19	in this state by a school district or a community-based
20	organization serves the function of an elementary school by
21	providing elementary education at one or more program facilities.
22	(c) A determination by the commissioner under Subsection
23	<u>(b):</u>
24	(1) does not entitle a Head Start program to receive

1	<u>state funds for which the program would not otherwise be eligible;</u>
2	(2) may not reduce the amount of federal grant funds
3	available for school districts and open-enrollment charter
4	schools; and
5	(3) may not be appealed.
6	SECTION 2. This Act takes effect immediately if it receives
7	a vote of two-thirds of all the members elected to each house, as
8	provided by Section 39, Article III, Texas Constitution. If this
9	Act does not receive the vote necessary for immediate effect, this
10	Act takes effect September 1, 2009.
