4	SECTION 1. Chapter 161, Human Resources Code, is amended by
5	adding Subchapter F to read as follows:
6	SUBCHAPTER F. FALL PREVENTION AWARENESS
7	Sec. 161.151. LEGISLATIVE FINDINGS. The legislature finds
8	that:
9	(1) in 2008, 1.14 million older Texans were expected
10	to sustain falls;
11	(2) the risk factors associated with falling increase
12	with age;
13	(3) approximately 20 to 30 percent of older adults who
14	fall suffer moderate to severe injuries, resulting in almost 80,000
15	hospitalizations annually and constituting 40 percent of all
16	nursing home placements;
17	(4) according to the Centers for Disease Control of
18	the United States Public Health Service, the total direct cost of
19	all fall-related injuries in 2000 for people 65 years of age and
20	older exceeded \$19 billion nationwide; and
21	(5) research shows that a well-designed fall
22	prevention program that includes risk factor assessments, a focused
23	physical activity program, and improvement of the home environment
24	can reduce the incidence of falls by 30 to 50 percent.

Sec. 161.152. FALL PREVENTION AWARENESS WEEK. The week 1 that begins on the first Sunday of each year that falls after the 2 3 date of the autumnal equinox is declared "Fall Prevention Awareness Week." 4 5 Sec. 161.153. FALL PREVENTION POLICY. The department may develop recommendations to: 6 7 (1) raise public awareness about fall prevention; (2) educate older adults and individuals who provide 8 care to older adults about best practices to reduce the incidence 9 10 and risk of falls among older adults; (3) encourage state and local governments and the 11 12 private sector to promote policies and programs that help reduce the incidence and risk of falls among older adults; 13 14 (4) encourage area agencies on aging to include fall 15 prevention education in their services; 16 (5) develop a system for reporting falls to improve 17 available information on falls; and (6) incorporate fall prevention guidelines into state 18 19 and local planning documents that affect housing, transportation, parks, recreational facilities, and other public facilities. 20 21 SECTION 2. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as 22 provided by Section 39, Article III, Texas Constitution. If this 23 24 Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2009. 25
