- 2 relating to a physician's delegation of prescriptive authority to
- 3 physician assistants or advanced practice nurses.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Sections 157.0511(b) and (b-1), Occupations
- 6 Code, are amended to read as follows:
- 7 (b) A physician may delegate the carrying out or signing of
- 8 a prescription drug order for a controlled substance only if:
- 9 (1) the prescription is for a controlled substance
- 10 listed in Schedule [Schedules] III, IV, or V as established by the
- 11 commissioner of public health under Chapter 481, Health and Safety
- 12 Code;
- 13 (2) the prescription, including a refill of the
- 14 prescription, is for a period not to exceed 90 [30] days;
- 15 (3) with regard to the refill of a prescription, the
- 16 refill is authorized after consultation with the delegating
- 17 physician and the consultation is noted in the patient's chart; and
- 18 (4) with regard to a prescription for a child less than
- 19 two years of age, the prescription is made after consultation with
- 20 the delegating physician and the consultation is noted in the
- 21 patient's chart.
- 22 (b-1) The board shall adopt rules that require a physician
- 23 who delegates the carrying out or signing of a prescription drug
- 24 order under this subchapter to register with the board the name and

- 1 license number of the physician assistant or advanced practice
- 2 nurse [maintain records that show when and] to whom a delegation is
- 3 made. The board may <u>develop</u> and use an electronic online <u>delegation</u>
- 4 registration process for registration under this subsection
- 5 [access the physician's records under this subsection as necessary
- 6 for an investigation].
- 7 SECTION 2. Sections 157.053(a) and (e), Occupations Code,
- 8 are amended to read as follows:
- 9 (a) In this section, "primary practice site" means:
- 10 (1) the practice location of a physician at which the
- 11 physician spends the majority of the physician's time;
- 12 (2) a licensed hospital, a licensed long-term care
- 13 facility, or a licensed adult care center where both the physician
- 14 and the physician assistant or advanced practice nurse are
- 15 authorized to practice;
- 16 (3) a clinic operated by or for the benefit of a public
- 17 school district to provide care to the students of that district and
- 18 the siblings of those students, if consent to treatment at that
- 19 clinic is obtained in a manner that complies with Chapter 32, Family
- 20 Code;
- 21 (4) the residence of an established patient; [ex]
- 22 (5) another location at which the physician is
- 23 physically present with the physician assistant or advanced
- 24 practice nurse; or
- 25 (6) a practice location providing care for established
- 26 patients for a physician assistant or advanced practice nurse who
- 27 practices on-site with the physician more than 50 percent of the

- 2 (e) A physician's authority to delegate the carrying out or
- 3 signing of a prescription drug order is limited to:
- 4 (1) three physician assistants or advanced practice
- 5 nurses or their full-time equivalents practicing at the physician's
- 6 primary practice site or at an alternate practice site under
- 7 Section 157.0541 <u>unless a waiver is granted under Section</u>
- 8 157.0542(b-1); and
- 9 (2) the patients with whom the physician has
- 10 established or will establish a physician-patient relationship.
- SECTION 3. Sections 157.0541(a), (c), and (e), Occupations
- 12 Code, are amended to read as follows:
- 13 (a) In this section, "alternate site" means a practice site:
- 14 (1) where services similar to the services provided at
- 15 the delegating physician's primary practice site are provided; and
- 16 (2) located within 75 [60] miles of the delegating
- 17 physician's residence or primary practice site.
- 18 (c) Physician supervision is adequate for the purposes of
- 19 this section if the delegating physician:
- 20 (1) is on-site with the advanced practice nurse or
- 21 physician assistant at least 10 [20] percent of the hours of
- 22 operation of the site each month that the physician assistant or
- 23 <u>advanced practice nurse is acting with delegated prescriptive</u>
- 24 authority, is available while on-site to see, diagnose, treat, and
- 25 provide care to those patients for services provided or to be
- 26 provided by the physician assistant or advanced practice nurse to
- 27 whom the physician has delegated prescriptive authority, and is not

- 1 prohibited by contract from seeing, diagnosing, or treating a
- 2 patient for services provided or to be provided by the physician
- 3 assistant or advanced practice nurse under delegated prescriptive
- 4 <u>authority [time]</u>;
- 5 (2) reviews at least 10 percent of the medical charts,
- 6 including through electronic review of the charts from a remote
- 7 <u>location, for each advanced practice nurse or physician assistant</u>
- 8 at the site; and
- 9 (3) is available through direct telecommunication for
- 10 consultation, patient referral, or assistance with a medical
- 11 emergency.
- 12 (e) Unless a waiver is granted under Section 157.0542(b-1),
- 13 the [The] combined number of advanced practice nurses and physician
- 14 assistants to whom a physician may delegate under this section and
- 15 at a primary practice site under Section 157.053 may not exceed
- 16 three physician assistants or advanced practice nurses or the
- 17 full-time equivalent of three physician assistants or advanced
- 18 practice nurses.
- 19 SECTION 4. Section 157.0542, Occupations Code, is amended
- 20 by adding Subsections (b-1), (b-2), and (b-3) to read as follows:
- 21 (b-1) If the board determines that the types of health care
- 22 services provided by a physician assistant or advanced practice
- 23 nurse under Section 157.0541 are limited in nature and duration and
- 24 are within the scope of delegated authority under this subchapter,
- 25 as defined by board rule, and that patient health care will not be
- 26 adversely affected, the board may modify or waive:
- 27 (1) the limitation on the number of physician

- 1 assistants or advanced practice nurses, or their full-time
- 2 equivalents, if the board does not authorize more than six
- 3 physician assistants or advanced practice nurses or their full-time
- 4 equivalents;
- 5 (2) the mileage limitation; or
- 6 (3) the on-site supervision requirements, except that
- 7 the physician must be available on-site at regular intervals and
- 8 when on-site the physician must be available to treat patients.
- 9 (b-2) A modification or waiver granted under this section
- 10 may not validate or authorize a contract provision that prohibits a
- 11 physician from seeing, diagnosing, or treating any patient.
- 12 (b-3) In granting a modification or waiver under Subsection
- 13 (b-1), the board may not limit the delegation authority of the
- 14 physician to requirements less stringent than the requirements
- 15 <u>established under Section 157.0541(a)(2) or Section 157.0541(e) or</u>
- 16 more stringent than the requirements established under Section
- 17 157.0541(c)(1).
- SECTION 5. Subchapter B, Chapter 157, Occupations Code, is
- 19 amended by adding Section 157.0543 to read as follows:
- Sec. 157.0543. VOLUNTARY CHARITY CARE AT NONPROFIT CLINIC.
- 21 (a) A physician may delegate the carrying out or signing of a
- 22 prescription drug order to a physician assistant or advanced
- 23 practice nurse who:
- 24 (1) has delegation authority under Section 157.052,
- 25 <u>157.053</u>, <u>157.054</u>, or <u>157.0541</u>; and
- 26 (2) provides without remuneration and in accordance
- 27 with board rules voluntary charity health care services at a clinic

- 1 run by or sponsored by a nonprofit organization.
- 2 (b) A delegation under this section does not require
- 3 <u>additional on-site supervision or chart review.</u>
- 4 SECTION 6. Not later than January 31, 2010, the Texas
- 5 Medical Board shall adopt the rules necessary to implement Chapter
- 6 157, Occupations Code, as amended by this Act.
- 7 SECTION 7. The changes in law made by this Act apply only to
- 8 a physician's delegation of prescriptive authority made on or after
- 9 February 1, 2010.
- 10 SECTION 8. This Act takes effect September 1, 2009.
