17	Sec. 6606.003. FINDINGS OF BENEFIT AND PURPOSE. (a) The			
18	district is created to serve a public use and benefit.			
19	(b) All land and other property included in the district			
20	will benefit from the works and projects that are to be accomplished			
21	by the district under powers conferred by Section 59, Article XVI			
22	Texas Constitution.			
23	(c) The district is essential to accomplish the purposes of			
24	Section 59, Article XVI, Texas Constitution.			

- 1 Sec. 6606.004. DISTRICT TERRITORY. The district territory
- 2 is coextensive with the boundaries of Starr County, Texas.

- 4 SUBCHAPTER B. BOARD OF DIRECTORS
- 5 Sec. 6606.051. DIRECTORS. (a) The district is governed by
- 6 a board of five directors consisting of the Commissioners Court of
- 7 Starr County.
- 8 (b) Service on the board is an additional duty of office for
- 9 a member of the Commissioners Court of Starr County.

- SUBCHAPTER C. POWERS AND DUTIES
- Sec. 6606.101. GENERAL POWERS AND DUTIES. The district has
- 13 all rights, powers, privileges, functions, and duties provided by
- 14 the general law of this state applicable to a drainage district
- 15 created under Section 59, Article XVI, Texas Constitution,
- 16 including Chapters 49 and 56, Water Code.
- 17 Sec. 6606.102. CONFIRMATION ELECTION. (a) The board shall
- 18 hold an election to confirm the creation of the district.
- 19 (b) Section 41.001(a), Election Code, does not apply to a
- 20 confirmation election under this section.
- 21 <u>(c) Except as provided by this section, the confirmation</u>
- 22 election must be conducted as provided by Sections 49.102(a)-(f),
- 23 Water Code, and the Election Code.
- 24 (d) The district is not required to elect directors at the
- 25 confirmation election.
- Sec. 6606.103. UTILITY PROPERTY EXEMPTION FROM IMPACT FEES,
- 27 STANDBY FEES, AND ASSESSMENTS. The district may not impose an

- 1 impact fee, standby fee, or assessment on the property, including
- 2 the equipment, rights-of-way, easements, facilities, or
- 3 <u>improvements</u>, of:
- 4 (1) an electric utility or a power generation company
- 5 as defined by Section 31.002, Utilities Code;
- 6 (2) a gas utility as defined by Section 101.003 or
- 7 <u>121.001</u>, <u>Utilities Code</u>;
- 8 (3) a telecommunications provider as defined by
- 9 Section 51.002, Utilities Code; or
- 10 (4) a person who provides to the public cable
- 11 television or advanced telecommunications services.
- 12 SECTION 2. (a) The legal notice of the intention to
- 13 introduce this Act, setting forth the general substance of this
- 14 Act, has been published as provided by law, and the notice and a
- 15 copy of this Act have been furnished to all persons, agencies,
- 16 officials, or entities to which they are required to be furnished
- 17 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 18 Government Code.
- 19 (b) The governor, one of the required recipients, has
- 20 submitted the notice and Act to the Texas Commission on
- 21 Environmental Quality.
- (c) The Texas Commission on Environmental Quality has filed
- 23 its recommendations on this Act with the governor, the lieutenant
- 24 governor, and the speaker of the house of representatives within
- 25 the required time.
- 26 (d) All requirements of the constitution and laws of this
- 27 state and the rules and procedures of the legislature with respect

- 1 to the notice, introduction, and passage of this Act are fulfilled
- 2 and accomplished.
- 3 SECTION 3. If the creation of the district is not confirmed
- 4 at a confirmation election held under Section 1 of this Act before
- 5 September 1, 2011, this Act and Chapter 6606, Special District
- 6 Local Laws Code, as added by this Act, expire on that date.
- 7 SECTION 4. This Act takes effect September 1, 2009.
