- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 204.123(a), Labor Code, is amended to
- 6 read as follows:
- 7 (a) If, on September 1 of a year, the commission determines
- 8 that the amount in the compensation fund will exceed 100 percent of
- 9 its floor as computed under Section 204.061 on the next October 1
- 10 computation date, the commission shall transfer from the holding
- 11 fund created under Section 204.122:
- 12 (1) from the first \$160 million deposited in the
- 13 holding fund in any state fiscal biennium:
- 14 (A) <u>50</u> [during the state fiscal biennium ending
- 15 August 31, 2007:
- 16 [(i) 67] percent to the Texas Enterprise Fund
- 17 created under Section 481.078, Government Code, except that the
- 18 amount transferred under this paragraph may not exceed the amount
- 19 appropriated by the legislature to the Texas Enterprise Fund in
- 20 that biennium; and
- (B) 50 $\left[\frac{\text{(ii)}}{33}\right]$ percent to the skills
- 22 development fund created under Section 303.003, except that the
- 23 amount transferred under this paragraph may not exceed the amount
- 24 appropriated by the legislature to the skills development program

- 1 strategies and activities in that biennium; and
- 2 [(B) during any state fiscal biennium beginning
- 3 on or after September 1, 2007:
- 4 [(i) 75 percent to the Texas Enterprise
- 5 Fund created under Section 481.078, Government Code, except that
- 6 the amount transferred under this paragraph may not exceed the
- 7 amount appropriated by the legislature to the Texas Enterprise Fund
- 8 in that biennium; and
- 9 [(ii) 25 percent to the skills development
- 10 fund created under Section 303.003, except that the amount
- 11 transferred under this paragraph may not exceed the amount
- 12 appropriated by the legislature to the skills development program
- 13 strategies and activities in that biennium; and]
- 14 (2) any remaining amount in the holding fund after the
- 15 distribution under Subdivision (1) to the training stabilization
- 16 fund created under Section 302.101.
- 17 SECTION 2. This Act takes effect immediately if it receives
- 18 a vote of two-thirds of all the members elected to each house, as
- 19 provided by Section 39, Article III, Texas Constitution. If this
- 20 Act does not receive the vote necessary for immediate effect, this
- 21 Act takes effect September 1, 2009.
