(a) Ιn this section: 8 (1) "Salary schedule" means the minimum salary 9 schedule under Section 21.402 or a comparable salary schedule used 10 by a school district that specifies salary amounts based on an 11 12 employee's level of experience. 13 (2) "Service record" means a school district document 14 that indicates the total years of service provided to the district by a classroom teacher, librarian, counselor, or nurse. 15 (b) On request by a classroom teacher, librarian, 16 counselor, or nurse or by the school district employing one of those 17 individuals, a school district that previously employed the 18 individual shall provide a copy of the individual's service record 19 to the school district employing the individual. The district must 20 provide the copy not later than the 30th day after the later of: 21 22 (1) the date the request is made; or
