22	SECTION 2. (a) Notwithstanding Chapter 245, Local
23	Government Code, the change in law made by Section 212.0155, Local
24	Government Code, as amended by this Act, applies to approval of a

1 plat filed on or after the effective date of this Act or before the 2 effective date of this Act if the approval of a plat filed before 3 the effective date of this Act is not final. A plat filed and 4 approved before the effective date of this Act is governed by the 5 law in effect immediately before that date, and that law is 6 continued in effect for that purpose.

7 (b) The change in law made by Section 212.0155, Local 8 Government Code, as amended by this Act, does not apply to a lawsuit 9 filed before the effective date of this Act. That section applies 10 to land that is the subject of a lawsuit filed before the effective 11 date of this Act on the date the decision in that lawsuit becomes 12 final or the suit is otherwise terminated.

13 SECTION 3. This Act takes effect immediately if it receives 14 a vote of two-thirds of all the members elected to each house, as 15 provided by Section 39, Article III, Texas Constitution. If this 16 Act does not receive the vote necessary for immediate effect, this 17 Act takes effect on the 91st day after the last day of the 18 legislative session.
