5	SECTION 1. Section 26.08(n), Tax Code, is amended to read as

8	school district whose maintenance and operations tax rate for the
9	2005 tax year was \$1.50 or less per \$100 of taxable value is[ $\div$
10	[(1) for the 2006 tax year, the sum of the rate that is
11	equal to 88.67 percent of the maintenance and operations tax rate
12	adopted by the district for the 2005 tax year, the rate of \$0.04 per
13	\$100 of taxable value, and the district's current debt rate; and
14	[(2) for the 2007 and subsequent tax years,
15	lesser of the following:
16	(1) [ $(A)$ ] the sum of the following:
17	$\underline{\text{(A)}}$ [ $\frac{\text{(i)}}{\text{(i)}}$ ] the rate per \$100 of taxable value that
18	is equal to the product of the state compression percentage, as

- 14 SECTION 2. (a) The change in law made by this Act applies
- 15 to the ad valorem tax rate of a school district beginning with the
- 16 2009 tax year, except as provided by Subsection (b) of this section.
- 17 (b) If the governing body of a school district adopted an ad
- 18 valorem tax rate for the school district for the 2009 tax year
- 19 before the effective date of this Act, the change in law made by
- 20 this Act applies to the ad valorem tax rate of that school district
- 21 beginning with the 2010 tax year, and the law in effect when the tax
- 22 rate was adopted applies to the 2009 tax year with respect to that
- 23 school district.
- 24 SECTION 3. This Act takes effect immediately if it receives
- 25 a vote of two-thirds of all the members elected to each house, as
- 26 provided by Section 39, Article III, Texas Constitution. If this
- 27 Act does not receive the vote necessary for immediate effect, this
