- 2 relating to abstinence education in public schools.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Section 28.004, Education Code, is amended by
- 5 amending Subsections (e) and (g) and adding Subsection (m) to read
- 6 as follows:
- 7 (e) Any course materials and instruction relating to human
- 8 sexuality, sexually transmitted diseases, or human
- 9 immunodeficiency virus or acquired immune deficiency syndrome
- 10 shall be selected by the board of trustees with the advice of the
- 11 local school health advisory council and must:
- 12 (1) present abstinence from sexual activity as the
- 13 healthiest [preferred] choice of behavior [in relationship to all
- 14 sexual activity] for unmarried persons of school age;
- 15 (2) devote more attention to abstinence from sexual
- 16 activity than to any other behavior;
- 17 (3) emphasize that abstinence from sexual activity, if
- 18 used consistently and correctly, is the only <u>certain way to prevent</u>
- 19 [method that is 100 percent effective in preventing] pregnancy and
- 20 $[\tau]$ sexually transmitted diseases, <u>including</u> $[\frac{\text{infection with}}{\text{or such the second of the second of$
- 21 human immunodeficiency virus <u>and</u> [or] acquired immune deficiency
- 22 syndrome, and the emotional trauma that may be associated with
- 23 adolescent sexual activity;
- 24 (4) include only scientifically accurate information

- 1 about the effectiveness of contraceptives and methods of reducing
- 2 the risk of sexually transmitted diseases and teach contraception
- 3 in terms of typical use rates, if instruction on contraception is
- 4 included in the curriculum content [direct adolescents to a
- 5 standard of behavior in which abstinence from sexual activity
- 6 before marriage is the most effective way to prevent pregnancy,
- 7 sexually transmitted diseases, and infection with human
- 8 immunodeficiency virus or acquired immune deficiency syndrome];
- 9 and
- 10 (5) not discourage the use by students who are
- 11 sexually active of any form of contraception or method approved by
- 12 the United States Food and Drug Administration of reducing the risk
- 13 of transmission of sexually transmitted diseases [teach
- 14 contraception and condom use in terms of human use reality rates
- 15 instead of theoretical laboratory rates, if instruction on
- 16 contraception and condoms is included in curriculum content].
- 17 (g) A school district that provides human sexuality
- 18 instruction may separate students according to gender [sex] for
- 19 instructional purposes.
- 20 (m) In this section:
- 21 (1) "Scientifically accurate information" means
- 22 <u>information that is:</u>
- (A) verified or supported by research conducted
- 24 in compliance with scientific methods;
- (B) published in peer reviewed journals, if
- 26 appropriate; and
- (C) recognized as accurate and objective by

- 1 professional organizations and agencies with expertise in the
- 2 relevant field, including:
- 3 <u>(i) the Centers for Disease Control and</u>
- 4 Prevention;
- 5 (ii) the American Public Health
- 6 Association;
- 7 (iii) the Society for Adolescent Medicine;
- 8 <u>(iv) the American Academy of Pediatrics;</u>
- 9 and
- 10 <u>(v) the American College of Obstetricians</u>
- 11 and Gynecologists.
- 12 (2) "Typical use rate" means the rate of failure for a
- 13 method of contraception when that method is not used by a person for
- 14 each act of sexual intercourse or when that method is not used by a
- 15 person for each act according to the instructions for that method.
- 16 The rate is identical to the rate defined as the typical use rate by
- 17 the United States Food and Drug Administration.
- SECTION 2. This Act applies beginning with the 2009-2010
- 19 school year.
- 20 SECTION 3. This Act takes effect immediately if it receives
- 21 a vote of two-thirds of all the members elected to each house, as
- 22 provided by Section 39, Article III, Texas Constitution. If this
- 23 Act does not receive the vote necessary for immediate effect, this
- 24 Act takes effect September 1, 2009.
