Sec. 8331.104. APPROVAL OF ROAD PROJECT. (a) The district not undertake a road project authorized by Section 8331.103 may unless:

each municipality or county that will operate and maintain the road has approved the plans and specifications of the road project, if a municipality or county will operate and maintain the road; or

the Texas Transportation Commission has approved the plans and specifications of the road project, if the state will operate and maintain the road.
