- 4 SECTION 2. The change in law made by this Act in amending
- 5 Section 28.03(b), Penal Code, applies only to an offense committed
- 6 on or after the effective date of this Act. An offense committed
- 7 before the effective date of this Act is covered by the law in
- 8 effect when the offense was committed, and the former law is
- 9 continued in effect for that purpose. For purposes of this section,
- 10 an offense is committed before the effective date of this Act if any
- 11 element of the offense occurred before that date.
- 12 SECTION 3. This Act takes effect September 1, 2009.
