5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Section 70.006, Property Code, is amended by
7	adding Subsections $(b-1)$, $(b-2)$, $(b-3)$, and (g) to read as follows:
8	(b-1) A holder of a possessory lien under Section 70.001 who
9	is required to give notice to a lienholder of record under this
10	section must include in the notice:
11	(1) the physical address of the real property at which
12	the repairs to the motor vehicle, motorboat, vessel, or outboard
13	<pre>motor were made;</pre>
14	(2) the legal name of the person that holds the
15	possessory lien for which the notice is required;
16	(3) the social security number, taxpayer
17	identification number, or employer identification number, as
18	applicable, of the person that holds the possessory lien for which
19	the notice is required; and
20	(4) a signed copy of the work order authorizing the
21	repairs on the motor vehicle, motorboat, vessel, or outboard motor.
22	(b-2) If the holder of a possessory lien required to give
23	notice in accordance with Subsection (b-1) does not comply with

that subsection, a lien recorded on the certificate of title of the

- 1 motor vehicle, motorboat, vessel, or outboard motor is superior to
- 2 the possessory lienholder's lien.
- 3 (b-3) A person commits an offense if the person knowingly
- 4 provides false or misleading information in a notice required by
- 5 this section. An offense under this subsection is a Class B
- 6 misdemeanor.
- 7 (g) After providing notice in accordance with this section,
- 8 <u>a holder of a possessory lien under Section 70.001 shall make</u>
- 9 commercially reasonable efforts to allow an owner and each
- 10 lienholder of record to inspect or arrange an inspection of the
- 11 motor vehicle, motorboat, vessel, or outboard motor by a qualified
- 12 professional to verify that the repairs were made.
- SECTION 2. The changes in law made by this Act apply only to
- 14 a possessory lien on a motor vehicle, motorboat, vessel, or
- 15 outboard motor the possession of which is obtained on or after the
- 16 effective date of this Act. A possessory lien on a motor vehicle,
- 17 motorboat, vessel, or outboard motor the possession of which was
- 18 obtained before that date is governed by the law in effect at the
- 19 time possession was obtained, and the former law is continued in
- 20 effect for that purpose.
- 21 SECTION 3. This Act takes effect September 1, 2009.
