4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter B, Chapter 531, Government Code, is
6	amended by adding Section 531.0226 to read as follows:
7	Sec. 531.0226. STUDY REGARDING COMPREHENSIVE SUBSTANCE
8	ABUSE TREATMENT. (a) The commission shall conduct a study
9	regarding the cost-effectiveness of providing comprehensive
10	substance abuse treatment, as described by Section 32.024(ff),
11	Human Resources Code, to Medicaid recipients who are at least 21
12	years of age.
13	(b) To evaluate the cost-effectiveness of providing
14	comprehensive substance abuse treatment to Medicaid recipients,
15	the commission shall identify and use specific outcome measures.
16	The outcome measures must be measured in three consecutive years,
17	including the year before the year in which the recipient receives
18	comprehensive substance abuse treatment, the year in which the
19	treatment is first provided to the recipient, and the year
20	following the year in which the treatment is first provided to the
21	recipient. The study must include, for Medicaid recipients who
22	receive comprehensive substance abuse treatment, at least the
23	following outcome measures:
24	(1) the average annual cost per recipient of a

1 recipient's treatment under the Medicaid program, other than the 2 comprehensive substance abuse treatment, including inpatient services other than inpatient labor and delivery services, 3 outpatient services, and pharmaceutical and ancillary services; 4 5 (2) the average annual cost per recipient of the comprehensive substance abuse treatment; and 6 7 (3) the average annual number, per recipient, of: 8 (A) inpatient days; emergency department visits; and 9 (B) 10 (C) outpatient visits. (c) To evaluate cost and utilization trends among Medicaid 11 12 recipients who are at least 21 years of age and with respect to whom there is no evidence of a substance abuse disorder, the commission 13 shall collect data regarding the outcome measures listed in 14 15 Subsections (b)(1) and (3) for the same period described by 16 Subsection (b). 17 (d) In conducting the study, the commission shall ensure that outcome data is evaluated using: 18 19 (1) appropriate demographic categories, including recipient age, disability, and income; and 20 21 (2) the type of service delivery model through which the recipient received services through Medicaid, including the 22 fee-for-service, primary care case management, and health 23 24 maintenance organization models. (e) Using the data collected during the study, the 25 26 commission shall evaluate cost and utilization trends and whether the provision of comprehensive substance abuse treatment through 27

the state Medicaid program results in an increase in overall 1 2 Medicaid spending. The commission shall prepare a report of the study data and the commission's determination and, not later than 3 December 1, 2012, submit the report to the governor, the state 4 5 auditor, and the Legislative Budget Board. 6 (f) If the commission determines that the provision of 7 comprehensive substance abuse treatment through the state Medicaid 8 program has resulted in an increase in overall Medicaid spending, the commission: 9 10 (1) may not continue to provide those services to a Medicaid recipient who is at least 21 years of age; and 11 12 (2) shall, in the report required by Subsection (e), recommend the repeal of Section 32.024(ff), Human Resources Code. 13 14 (g) This section expires January 1, 2013. 15 SECTION 2. Section 32.024, Human Resources Code, is amended by adding Subsection (ff) to read as follows: 16 17 (ff) Except as otherwise provided by this subsection, the department shall provide comprehensive substance abuse treatment 18 19 under the medical assistance program to a person who is at least 21 years of age, has a substance abuse disorder, and otherwise 20 qualifies for medical assistance. The department may not provide 21 the treatment if, based on the study conducted under Section 22 531.0226, Government Code, a determination is made that the 23 24 treatment resulted in an increase in overall medical assistance program spending. Comprehensive substance abuse treatment 25 26 includes assessment, residential detoxification, outpatient detoxification, methadone maintenance, residential services, 27

1 specialized residential services for women, outpatient chemical

2 dependency counseling, and any other necessary services as

3 determined by the department.

SECTION 3. Not later than December 1, 2009, the Health and Human Services Commission shall submit to the Legislative Budget Board for approval the commission's proposed methodology, including outcome measures selected, for the cost-effectiveness study required by Section 531.0226, Government Code, as added by this Act.

10 SECTION 4. If before implementing any provision of this Act 11 a state agency determines that a waiver or authorization from a 12 federal agency is necessary for implementation of that provision, 13 the agency affected by the provision shall request the waiver or 14 authorization and may delay implementing that provision until the 15 waiver or authorization is granted.
