- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 604.002, Business & Commerce Code, is
- 6 amended to read as follows:
- 7 Sec. 604.002. INAPPLICABILITY OF CHAPTER. This chapter
- 8 does not apply to a stored value card that:
- 9 (1) is issued by:
- 10 (A) a financial institution acting as a financial
- 11 agent of the United States or this state;
- 12 (B) a federally insured financial institution,
- 13 as defined by Section 201.101, Finance Code, if the financial
- 14 institution is primarily liable for the card as the issuing
- 15 principal; or
- 16 (C) an air carrier holding a certificate of
- 17 public convenience and necessity under Title 49, United States
- 18 Code;
- 19 (2) is issued as a prepaid calling card by a prepaid
- 20 calling card company regulated under Section 55.253, Utilities
- 21 Code;
- 22 (3) is distributed by the issuer to a person under an
- 23 awards, rewards, loyalty, incentive, rebate, or promotional
- 24 program and is not issued or reloaded in exchange for money tendered

- 1 by the cardholder;
- 2 (4) is sold below face value or donated to:
- 3 (A) an employee of the seller or issuer;
- 4 (B) a nonprofit or charitable organization; or
- 5 (C) an educational institution for fund-raising
- 6 purposes; or
- 7 (5) does not expire and for which the seller does not
- 8 charge a fee [other than a fee] described in Section 604.051.
- 9 SECTION 2. The heading to Subchapter B, Chapter 604,

- 12 SECTION 3. Section 604.051, Business & Commerce Code, is

- 14 Sec. 604.051. FEES AND CHARGES ASSOCIATED WITH [RELATED TO
- 15 ISSUANCE AND HANDLING OF | CARD PROHIBITED. The [If disclosed as
- 16 required by Subchapter C, the] issuer of a stored value card may not
- 17 impose or [and] collect a fee associated with a stored value card,
- 18 including [reasonable]:
- 19 (1) a handling fee in connection with the issuance of
- 20 or adding of value to the card;
- 21 (2)  $\underline{an}$  access fee for a card transaction conducted at
- 22 an unmanned teller machine, as defined by Section 59.301, Finance
- 23 Code; [<del>and</del>]
- 24 (3)  $\underline{a}$  reissue or replacement charge if an expired or
- 25 lost card is reissued or replaced; or
- 26 (4) a periodic fee or other charge that causes the
- 27 unredeemed balance of the card to decrease over time.

- 1 SECTION 4. Section 604.101, Business & Commerce Code, is
- 2 amended to read as follows:
- 3 Sec. 604.101. REQUIRED DISCLOSURE OF CERTAIN MATTERS
- 4 APPLICABLE TO CARD. An expiration date,  $[ext{or}]$  policy,  $[ext{fee}, ]$  or
- 5 other material restriction or contract term applicable to a stored
- 6 value card must be clearly and conspicuously disclosed at the time
- 7 the card is sold or issued to a person to enable the person to make
- 8 an informed decision before purchasing the card.
- 9 SECTION 5. Section 604.102, Business & Commerce Code, is
- 10 amended to read as follows:
- 11 Sec. 604.102. REQUIRED PRINTING OF CERTAIN DISCLOSURES. In
- 12 addition to the disclosure required under Section 604.101, a
- 13 disclosure regarding the expiration of a stored value card [or a
- 14 periodic fee that reduces the unredeemed value of a stored value
- 15 card] must be legibly printed on the card.
- SECTION 6. Section 604.103, Business & Commerce Code, is
- 17 amended to read as follows:
- 18 Sec. 604.103. VALIDITY OF CARD SOLD WITHOUT REQUIRED
- 19 DISCLOSURES. A stored value card sold without the disclosure
- 20 required by this subchapter of an expiration date, [or] policy,
- 21 [ $fee_{\tau}$ ] or other material restriction or contract term applicable to
- 22 the card is valid until redeemed or replaced.
- SECTION 7. Section 72.1016(a), Property Code, is amended to

- 25 (a) This section applies to a stored value card, as defined
- 26 by Section 604.001, Business & Commerce Code, other than a card:
- 27 (1) to which Chapter 604, Business & Commerce Code,

- 1 does not apply by operation of Sections 604.002(1)(A) and (C) and
- 2 604.002(2)-(4) [604.002(2)-(5)] of that code; or
- 3 (2) that is linked to and draws its value solely from a
- 4 deposit account subject to Chapter 73.
- 5 SECTION 8. The following provisions are repealed:
- 6 (1) Section 604.052, Business & Commerce Code; and
- 7 (2) Section 72.1016(d), Property Code.
- 8 SECTION 9. The changes in law made by this Act apply only to
- 9 a stored value card issued or activated on or after the effective
- 10 date of this Act. A stored value card issued or activated before
- 11 the effective date of this Act is governed by the law in effect when
- 12 the card was issued or activated, and the former law is continued in
- 13 effect for that purpose.
- 14 SECTION 10. This Act takes effect September 1, 2009.
