5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle F, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 8306 to read as follows:
8	CHAPTER 8306. XS RANCH MUNICIPAL UTILITY DISTRICT
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 8306.001. DEFINITIONS. In this chapter:
11	(1) "Board" means the district's board of directors.
12	(2) "Commission" means the Texas Commission on
13	Environmental Quality.
14	(3) "Director" means a board member.
15	(4) "District" means the XS Ranch Municipal Utility
16	District.
17	Sec. 8306.002. NATURE OF DISTRICT. The district is a
18	municipal utility district created under Section 59, Article XVI,
19	Texas Constitution.
20	Sec. 8306.003. CONFIRMATION AND DIRECTORS' ELECTION
21	REQUIRED. The temporary directors shall hold an election to
22	confirm the creation of the district and to elect five permanent
23	directors as provided by Section 49.102, Water Code.
24	Sec. 8306.004. CONSENT OF MUNICIPALITY REQUIRED. The

- 1 temporary directors may not hold an election under Section 8306.003
- 2 until each municipality in whose corporate limits or
- 3 extraterritorial jurisdiction the district is located, including
- 4 the City of Bastrop, has consented by ordinance or resolution to the
- 5 creation of the district and to the inclusion of land in the
- 6 district.
- 7 Sec. 8306.005. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. (a)
- 8 The district is created to serve a public purpose and benefit.
- 9 (b) The district is created to accomplish the purposes of:
- 10 (1) a municipal utility district as provided by
- 11 general law and Section 59, Article XVI, Texas Constitution; and
- 12 (2) Section 52, Article III, Texas Constitution, that
- 13 relate to the construction, acquisition, improvement, operation,
- 14 or maintenance of macadamized, graveled, or paved roads, or
- 15 improvements, including storm drainage, in aid of those roads.
- Sec. 8306.006. INITIAL DISTRICT TERRITORY. (a) The
- 17 district is initially composed of the territory described by
- 18 Section 2 of the Act creating this chapter.
- 19 (b) The boundaries and field notes contained in Section 2 of
- 20 the Act creating this chapter form a closure. A mistake made in the
- 21 field notes or in copying the field notes in the legislative process
- 22 does not affect the district's:
- 23 (1) organization, existence, or validity;
- 24 (2) right to issue any type of bond for the purposes
- 25 for which the district is created or to pay the principal of and
- 26 interest on a bond;
- 27 (3) right to impose a tax; or

1	(4) legality or operation.

3	SUBCHAPTER B. BOARD OF DIRECTORS
4	Sec. 8306.051. GOVERNING BODY; TERMS. (a) The district is
5	governed by a board of five elected directors.
6	(b) Except as provided by Section 8306.052, directors serve
7	staggered four-year terms.
8	Sec. 8306.052. TEMPORARY DIRECTORS. (a) The temporary
9	<pre>board consists of:</pre>
10	(1) Mark Engels;
11	(2) Mark Oldemeyer;
12	(3) James Michael Sulester, Jr.;
13	(4) William Faust; and
14	(5) Don Montague.
15	(b) Temporary directors serve until the earlier of:
16	(1) the date permanent directors are elected under
17	<u>Section 8306.003; or</u>
18	(2) the fourth anniversary of the effective date of
19	the Act creating this chapter.
20	(c) If permanent directors have not been elected under
21	Section 8306.003 and the terms of the temporary directors have
22	expired, successor temporary directors shall be appointed or
23	reappointed as provided by Subsection (d) to serve terms that
24	<pre>expire on the earlier of:</pre>
25	(1) the date permanent directors are elected under
26	Section 8306.003; or
27	(2) the fourth anniversary of the date of the

- 1 appointment or reappointment.
- 2 (d) If Subsection (c) applies, the owner or owners of a
- 3 majority of the assessed value of the real property in the district
- 4 may submit a petition to the commission requesting that the
- 5 commission appoint as successor temporary directors the five
- 6 persons named in the petition. The commission shall appoint as
- 7 successor temporary directors the five persons named in the
- 8 petition.
- 9 [Sections 8306.053-8306.100 reserved for expansion]
- 10 <u>SUBCHAPTER C. POWERS AND DUTIES</u>
- 11 Sec. 8306.101. GENERAL POWERS AND DUTIES. The district has
- 12 the powers and duties necessary to accomplish the purposes for
- 13 which the district is created.
- 14 Sec. 8306.102. MUNICIPAL UTILITY DISTRICT POWERS AND
- 15 DUTIES. The district has the powers and duties provided by the
- 16 general law of this state, including Chapters 49 and 54, Water Code,
- 17 applicable to municipal utility districts created under Section 59,
- 18 Article XVI, Texas Constitution.
- 19 Sec. 8306.103. AUTHORITY FOR ROAD PROJECTS. Under Section
- 20 52, Article III, Texas Constitution, the district may design,
- 21 acquire, construct, finance, issue bonds for, improve, operate,
- 22 maintain, and convey to this state, a county, or a municipality for
- 23 operation and maintenance macadamized, graveled, or paved roads, or
- 24 improvements, including storm drainage, in aid of those roads.
- Sec. 8306.104. ROAD STANDARDS AND REQUIREMENTS. (a) A road
- 26 project must meet all applicable construction standards, zoning and
- 27 subdivision requirements, and regulations of each municipality in

- 1 whose corporate limits or extraterritorial jurisdiction the road
- 2 project is located.
- 3 (b) If a road project is not located in the corporate limits
- 4 or extraterritorial jurisdiction of a municipality, the road
- 5 project must meet all applicable construction standards,
- 6 subdivision requirements, and regulations of each county in which
- 7 the road project is located.
- 8 <u>(c) If the state will maintain and operate the road, the</u>
- 9 Texas Transportation Commission must approve the plans and
- 10 specifications of the road project.
- 11 Sec. 8306.105. COMPLIANCE WITH MUNICIPAL ORDINANCE OR
- 12 RESOLUTION. (a) The district shall comply with all applicable
- 13 requirements of any ordinance or resolution that is adopted under
- 14 Section 54.016 or 54.0165, Water Code, and that consents to the
- 15 <u>creation of the district or to the inclusion of land in the</u>
- 16 <u>district</u>.
- 17 (b) Land in the district that is located in the City of
- 18 Bastrop's extraterritorial jurisdiction is subject to municipal
- 19 ordinances applicable to extraterritorial areas, unless the
- 20 municipality's governing body waives compliance.
- 21 Sec. 8306.106. CONTRACT WITH CERTAIN MUNICIPALITIES
- 22 REQUIRED. (a) The district may not exercise the powers and duties
- 23 of a municipal utility district under this chapter unless the
- 24 district enters into a written contract with any municipality in
- 25 whose extraterritorial jurisdiction the district is wholly or
- 26 partly located that:
- 27 (1) provides for the continuation of the

- 1 extraterritorial status of the district or the district's
- 2 annexation by the municipality;
- 3 (2) ensures that any development in the district
- 4 occurs in a manner that furthers the health, safety, and welfare of
- 5 the residents of the district; and
- 6 (3) includes other terms and consideration that the
- 7 municipality determines to be reasonable and appropriate.
- 8 (b) A contract under this section may be renewed or extended
- 9 for successive periods not to exceed 15 years.
- 10 (c) If the district does not enter into a contract under
- 11 this section before the later of September 1, 2009, or the 30th day
- 12 after the effective date of the Act creating this chapter, the
- 13 board, at the board's sole discretion, may adopt an order
- 14 dissolving the district if the district has no assets or
- 15 obligations. If an order dissolving the district is adopted under
- 16 this subsection, an original or certified copy of the order must be
- 17 filed with the commission and in the real property records of any
- 18 county in which the district is located.
- 19 Sec. 8306.107. EFFECT OF CHAPTER ON CITY OF BASTROP.
- 20 Nothing in this chapter abrogates, diminishes, or otherwise alters
- 21 any rights, powers, privileges, or functions of the City of Bastrop
- 22 provided by the general law of this state, including Chapter 42,
- 23 Local Government Code, and Chapter 54, Water Code, related to the
- 24 creation of special districts in its extraterritorial
- 25 jurisdiction.
- Sec. 8306.108. LIMITATION ON USE OF EMINENT DOMAIN. The
- 27 district may not exercise the power of eminent domain outside the

1 district to acquire a site or easement for: 2 (1) a road project authorized by Section 8306.103; or (2) a recreational facility as defined by Section 3 49.462, Water Code. 4 5 Sec. 8306.109. DIVISION OF DISTRICT. (a) The district may be divided into two or more new districts only if: 6 7 (1) the district has no outstanding bonded debt; 8 (2) the district is not imposing ad valorem taxes; and 9 (3) the requirements of Subsection (i) are satisfied. (b) This chapter applies to any new district created by the 10 division of the district, and a new district has all the powers and 11 12 duties of the district. (c) Any new district created by the division of the district 13 14 may not, at the time the new district is created, contain any land 15 outside the area described by Section 2 of the Act creating this 16 chapter. 17 (d) The board, on its own motion or on receipt of a petition signed by the owner or owners of a majority of the assessed value of 18 19 the real property in the district, may adopt an order dividing the district. 20 21 (e) The board may adopt an order dividing the district before or after the date the board holds an election under Section 22 23 8306.003 to confirm the district's creation. 24 (f) An order dividing the district shall: 25 (1) name each new district; (2) include the metes and bounds description of the 26

territory of each new district;

- 3 (4) provide for the division of assets and liabilities
- 4 between or among the new districts.
- 5 (g) On or before the 30th day after the date of adoption of
- 6 an order dividing the district, the district shall file the order
- 7 with the commission and record the order in the real property
- 8 records of each county in which the district is located.
- 9 (h) Any new district created by the division of the district
- 10 shall hold a confirmation and directors' election as required by
- 11 Section 8306.003.
- 12 (i) If the district is located wholly or partly in the
- 13 corporate limits or the extraterritorial jurisdiction of a
- 14 municipality, the district may not divide under this section unless
- 15 the municipality by resolution or ordinance first consents to the
- 16 <u>division of the district</u>. If the district is not located wholly or
- 17 partly in the corporate limits or the extraterritorial jurisdiction
- 18 of a municipality, the district may not divide under this section
- 19 unless the commissioners court of each county in which the district
- 20 is wholly or partly located first adopts a resolution or order in
- 21 support of the division of the district.
- 22 (j) Any new district created by the division of the district
- 23 must hold an election as required by this chapter to obtain voter
- 24 approval before the district may impose a maintenance tax or issue
- 25 bonds payable wholly or partly from ad valorem taxes.

- 5 Sec. 8306.201. AUTHORITY TO ISSUE BONDS AND OTHER
- 6 OBLIGATIONS. The district may issue bonds or other obligations
- 7 payable wholly or partly from ad valorem taxes, impact fees,
- 8 revenue, contract payments, grants, or other district money, or any
- 9 combination of those sources, to pay for any authorized district
- 10 purpose.
- Sec. 8306.202. TAXES FOR BONDS. At the time the district
- 12 issues bonds payable wholly or partly from ad valorem taxes, the
- 13 board shall provide for the annual imposition of a continuing
- 14 direct ad valorem tax, without limit as to rate or amount, while all
- or part of the bonds are outstanding as required and in the manner
- 16 provided by Sections 54.601 and 54.602, Water Code.
- 17 Sec. 8306.203. BONDS FOR ROAD PROJECTS. At the time of
- 18 issuance, the total principal amount of bonds or other obligations
- 19 issued or incurred to finance road projects and payable from ad
- 20 valorem taxes may not exceed one-fourth of the assessed value of the
- 21 real property in the district.

- 25 introduce this Act, setting forth the general substance of this
- 26 Act, has been published as provided by law, and the notice and a
- 27 copy of this Act have been furnished to all persons, agencies,

- 1 officials, or entities to which they are required to be furnished
- 2 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 3 Government Code.
- 4 (b) The governor, one of the required recipients, has
- 5 submitted the notice and Act to the Texas Commission on
- 6 Environmental Quality.
- 7 (c) The Texas Commission on Environmental Quality has filed
- 8 its recommendations relating to this Act with the governor, the
- 9 lieutenant governor, and the speaker of the house of
- 10 representatives within the required time.
- 11 (d) All requirements of the constitution and laws of this
- 12 state and the rules and procedures of the legislature with respect
- 13 to the notice, introduction, and passage of this Act are fulfilled

- 15 SECTION 4. This Act takes effect immediately if it receives
- 16 a vote of two-thirds of all the members elected to each house, as
- 17 provided by Section 39, Article III, Texas Constitution. If this
- 18 Act does not receive the vote necessary for immediate effect, this
- 19 Act takes effect September 1, 2009.
