- 2 relating to the authorization of certain reuse water system
- 3 contributions and discharges.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter B, Chapter 26, Water Code, is amended
- 6 by adding Section 26.0271 to read as follows:
- 7 Sec. 26.0271. PERMITS AUTHORIZING REUSE WATER SYSTEM
- 8 CONTRIBUTIONS AND DISCHARGES. (a) This section applies only to
- 9 wastewater treatment facilities operated by an agency of a
- 10 home-rule municipality with a population of one million or more.
- 11 (b) In any permit or amendment to a permit issued under this
- 12 chapter, at the request of the applicant the commission may
- 13 <u>authorize a wastewater treatment facility to contribute treated</u>
- 14 domestic wastewater produced by the facility as reclaimed water to
- 15 a reuse water system if the commission has approved the use of
- 16 reclaimed water from the wastewater treatment facility.
- 17 (c) In any permit or amendment to a permit issued under this
- 18 chapter, at the request of the applicant the commission shall
- 19 authorize, subject to any required approval by the United States
- 20 Environmental Protection Agency, a wastewater treatment facility
- 21 to:
- 22 (1) contribute reclaimed water into a reuse water
- 23 system operated by the agency; and
- 24 (2) discharge reclaimed water contributed to a reuse

- 1 water system at any outfall for which a discharge from the reuse
- 2 water system is authorized in any permit issued for any wastewater
- 3 treatment facility operated by the agency.
- 4 (d) For an effluent limitation violation occurring at an
- 5 outfall permitted for reuse water system discharges by more than
- 6 one wastewater treatment facility, the commission shall attribute
- 7 the violation to the wastewater treatment facility contributing the
- 8 reclaimed water causing the violation. For a violation that is not
- 9 directly attributable to a specific wastewater treatment facility,
- 10 the commission shall attribute the violation to the wastewater
- 11 treatment facility contributing the greatest volume of reclaimed
- 12 water to the reuse water system on the date of the violation.
- SECTION 2. (a) The change in law made by Section 26.0271,
- 14 Water Code, as added by this Act, applies only to permits or
- 15 amendments to permits issued on or after the effective date of this
- 16 Act. A permit or permit amendment that was issued before the
- 17 effective date of this Act is governed by the law in effect at the
- 18 time the permit or amendment to the permit was issued, and the
- 19 former law is continued in effect for that purpose.
- 20 (b) It is the intent of the legislature that the change in
- 21 law made by Section 26.0271, Water Code, as added by this Act, does
- 22 not in any way alter the current law related to permits, amendments
- 23 to permits, authorizations, and other approvals for the
- 24 contribution or discharge of reclaimed water, including the
- 25 commission's current reclaimed water rules, as applied to any
- 26 entity other than a wastewater treatment facility operated by an
- 27 agency of a home-rule municipality with a population of one million

- 1 or more, including a municipality with a population of less than one
- 2 million.
- 3 SECTION 3. This Act takes effect immediately if it receives
- 4 a vote of two-thirds of all the members elected to each house, as
- 5 provided by Section 39, Article III, Texas Constitution. If this
- 6 Act does not receive the vote necessary for immediate effect, this
- 7 Act takes effect September 1, 2009.
