7	SUBCHAPTER J. ADMINISTRATIVE AND CONTRACT PROVISIONS APPLICABLE TO
8	CERTAIN NONPROFIT CORPORATIONS LOCATED IN LARGE COUNTIES
9	Sec. 22.451. APPLICABILITY OF SUBCHAPTER. This subchapter
10	applies only to a nonprofit corporation:
11	(1) whose principal office is located in a county with
12	a population of 3.3 million or more; and
13	(2) that contracts with a local government
14	corporation.
15	Sec. 22.452. BOARD OF DIRECTORS TO REFLECT DIVERSITY OF
16	CONSTITUENTS. An appointment to a board of directors of a nonprofit
17	corporation described by Section 22.451 must be made with the
18	intent to ensure that the board reflects the diversity of the
19	constituency served by the nonprofit corporation.

Sec. 22.454. CONTRACTS FOR HISTORICALLY UNDERUTILIZED

ACT. A nonprofit corporation described by Section 22.451 is

subject to Chapter 552, Government Code, in the same manner as a

- 1 BUSINESSES. (a) A nonprofit corporation described by Section
- 2 22.451 shall make a reasonable effort to award contracts or
- 3 subcontracts associated with a project it operates, maintains, or
- 4 constructs to historically underutilized businesses.
- 5 (b) In this section, "historically underutilized business"
- 6 means:
- 7 (1) a corporation formed for the purpose of making a
- 8 profit in which at least 51 percent of all classes of the shares of
- 9 stock or other equitable securities is owned, managed, and in daily
- 10 operations controlled by one or more persons who have been
- 11 historically underutilized because of their identification as
- 12 members of certain groups, including African Americans, Hispanic
- 13 Americans, women, Asian Pacific Americans, and Native Americans,
- 14 who have suffered the effects of discriminatory practices or
- 15 similar invidious circumstances over which they have no control;
- 16 (2) a sole proprietorship formed for the purpose of
- 17 making a profit that is 100 percent owned and in daily operation is
- 18 controlled by a person described by Subdivision (1);
- 19 (3) a partnership formed for the purpose of making a
- 20 profit in which at least 51 percent of the assets and interest in
- 21 the partnership are owned by one or more persons described by
- 22 Subdivision (1) and who also have proportionate interest in the
- 23 control, daily operation, and management of the partnership's
- 24 affairs;
- 25 (4) a joint venture in which each entity in the joint
- 26 venture is a historically underutilized business; or
- 27 (5) a supplier contract between a historically

- 1 underutilized business and a prime contractor under which the
- 2 historically underutilized business is directly involved in the
- 3 manufacture or distribution of the supplies or materials or
- 4 otherwise warehouses and ships the supplies or materials.
- 5 SECTION 2. Section 22.454, Business Organizations Code, as
- 6 added by this Act, applies only to a contract that is entered into
- 7 on or after the effective date of this Act. A contract entered into
- 8 before the effective date of this Act is governed by the law in
- effect on the date the contract was entered into, and the former law
- 10 is continued in effect for that purpose.
- 11 SECTION 3. This Act takes effect immediately if it receives
- 12 a vote of two-thirds of all the members elected to each house, as
- 13 provided by Section 39, Article III, Texas Constitution. If this
- 14 Act does not receive the vote necessary for immediate effect, this
- 15 Act takes effect September 1, 2009.
