- 5 SECTION 1. Section 41.0105, Civil Practice and Remedies
- 6 Code, is amended to read as follows:
- 7 Sec. 41.0105. EVIDENCE RELATING TO AMOUNT OF ECONOMIC
- 8 DAMAGES. (a) In addition to any other limitation under law,
- 9 recovery of medical or health care expenses incurred is limited to
- 10 the amount actually paid or incurred by or on behalf of the
- 11 claimant.
- 12 (b) This section applies only to a health care liability
- 13 <u>claim under Chapter 74.</u>
- 14 (c) This section does not apply to a claim for future
- 15 medical or health care expenses.
- 16 SECTION 2. This Act applies only to an action commenced on
- 17 or after the effective date of this Act. An action that is
- 18 commenced before the effective date of this Act is governed by the
- 19 law applicable to the action immediately before the effective date
- 20 of this Act, and that law is continued in effect for that purpose.
- 21 SECTION 3. This Act takes effect immediately if it receives
- 22 a vote of two-thirds of all the members elected to each house, as
- 23 provided by Section 39, Article III, Texas Constitution. If this
