- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 ARTICLE 1. ENTITIES GIVEN 2013 SUNSET DATE
- 6 SECTION 1.01. TEXAS EDUCATION AGENCY. Section 7.004,
- 7 Education Code, is amended to read as follows:
- 8 Sec. 7.004. SUNSET PROVISION. The Texas Education Agency
- 9 is subject to Chapter 325, Government Code (Texas Sunset
- 10 Act). Unless continued in existence as provided by that chapter,
- 11 the agency is abolished September 1, 2013 [2012]. [In the review
- 12 of the agency by the Sunset Advisory Commission, as required by this
- 13 section, the sunset commission shall limit its review to the
- 14 appropriateness of recommendations made by the sunset commission to
- 15 the 79th Legislature. In the Sunset Advisory Commission's report
- 16 to the 80th Legislature, the sunset commission may include any
- 17 recommendations it considers appropriate.
- 18 SECTION 1.02. TRANSFER OF PURCHASING POWERS TO THE
- 19 COMPTROLLER OF PUBLIC ACCOUNTS OF THE STATE OF TEXAS. Sections
- 20 2151.0041(b) and (c), Government Code, are amended to read as
- 21 follows:
- 22 (b) The Sunset Advisory Commission shall evaluate the
- 23 transfer of powers and duties to the comptroller under Section
- 24 2151.004(d) and under House Bill 3560, Acts of the 80th

- 1 Legislature, Regular Session, 2007, and present to the <u>83rd</u> [82nd]
- 2 Legislature a report on its evaluation and recommendations in
- 3 relation to the transfer. The comptroller shall perform all duties
- 4 in relation to the evaluation that a state agency subject to review
- 5 under Chapter 325 would perform in relation to a review.
- 6 (c) Unless otherwise provided by the legislature by law, on 7 September 1, 2013 [2011]:
- 8 (1) the powers and duties transferred to the
- 9 comptroller under Section 2151.004(d) and under House Bill 3560,
- 10 Acts of the 80th Legislature, Regular Session, 2007, are
- 11 transferred to the Texas Facilities Commission;
- 12 (2) a reference in law to the comptroller relating to a
- 13 power or duty transferred under this subsection means the Texas
- 14 Facilities Commission;
- 15 (3) a rule or form adopted by the comptroller relating
- 16 to a power or duty transferred under this subsection is a rule or
- 17 form of the Texas Facilities Commission and remains in effect until
- 18 altered by the commission;
- 19 (4) all obligations, contracts, proceedings, cases,
- 20 negotiations, funds, and employees of the comptroller relating to a
- 21 power or duty transferred under this subsection are transferred to
- 22 the Texas Facilities Commission;
- 23 (5) all property and records in the custody of the
- 24 comptroller relating to a power or duty transferred under this
- 25 subsection and all funds appropriated by the legislature for
- 26 purposes related to a power or duty transferred under this
- 27 subsection are transferred to the Texas Facilities Commission; and
