13	technician authorizing the employee or technician to engage in the
14	fire protection sprinkler system business in this state.

18	department shall operate [may create] a specialized licensing or

21	(2) fire protection sprinkler technicians.

2	(b) A person may not install, alter, maintain, or service a

3	(2) makes certification decisions that are not subject
4	to approval by any other organization or the membership of an
5	affiliated organization and operates all financial matters related
6	to the certification organization's operation separately from the
7	affiliated organization;
8	(3) uses reliable testing mechanisms that are
9	objective, fair, job-related, and based on the applicant's
10	knowledge and skills necessary to function in the fire protection
11	sprinkler industry;
12	(4) establishes scores for successful completion of
13	certification at a level that protects the public by determining
14	whether the applicant is sufficiently knowledgeable to install,
15	repair, alter, maintain, and service fire protection sprinkler
16	systems that meet applicable code standards; and
17	(5) publishes and makes available to the public the
18	procedures used by the organization in examination construction and
19	validation, the eligibility requirements and determination
20	procedures, and the procedures for examination administration
21	including dates, locations, fees, result reporting,
22	recertification requirements, and grievance or appeals procedures.
23	(f) The state fire marshal may make an agreement, subject to
24	approval by the governor, with another state to allow licensing by
25	reciprocity.
26	SECTION 5. Section 6003.156, Insurance Code, is amended by

(a-1) The examination for a fire protection sprinkler 1 technician must test the applicant's knowledge of the installation, 2 repair, alteration, maintenance, and service of fire protection 3 sprinkler systems, in accordance with nationally accepted code 4 standards approved by the commissioner. 5 6 (f) A person who fails the examination for a fire protection 7 sprinkler technician license may not retake the examination before the 90th day after the date of the initial examination and must 8 submit a \$30 nonrefundable examination fee for each subsequent 9 10 attempt. SECTION 6. Section 6003.158, Insurance Code, is amended by 11 amending Subsection (b) and adding Subsection (c) to read as 12 follows: 13 14 (b) Except as provided by Subsection (c), participation 15 [Participation] in the continuing education programs is voluntary. 16 (c) A fire protection sprinkler technician must annually 17 complete at least eight hours of continuing education in accordance with comm<u>issioner rules.</u> 18 SECTION 7. Section 6003.201(a), Insurance Code, is amended 19 to read as follows: 20 An [Except as otherwise provided by this subsection, an] 21 (a) initial registration certificate or license is valid for a period 22 of two years [one year] from the date of issue and is renewable on 23 24 payment of the renewal fee. [An initial registration certificate or license issued on or after September 1, 1983, may be issued for a 25 26 period of less than one year and the renewal fee shall be prorated proportionally. 27

(b) A fire protection sprinkler technician is not required to hold a license under Chapter 6003, Insurance Code, as amended by this Act, before July 1, 2010.
