A BILL TO BE ENTITLED AN ACT

relating to parking privileges for veterans with disabilities. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-10 1-11 SECTION 1. Sections 681.008(a) and (b), Transportation 1-12 Code, are amended to read as follows:

1-13 (a) A vehicle may be parked for an unlimited period in a parking space or area that is designated specifically for persons with physical disabilities if [+ [(1)]] the vehicle: 1-14 1**-**15 1**-**16

(1) is being operated by or for the transportation of:

1-18 (A) the person who registered the vehicle under 1-19 Section 504.202(a)[+] or

1-20 1-21 [(B)] a person described by Section 504.202(b) if the vehicle is registered under that subsection; and

1-22 (B) displays [(2) there are displayed on the vehicle] special license plates issued under Section 504.202; or 1-23

(b) A vehicle on which license plates described 1-28 by Subsection (a)(2) or issued under Section 504.202 or Section 504.315(c), (d), (e), or (g) are displayed is exempt from the payment of a parking fee collected through a parking meter charged 1-29 1-30 1-31 by a governmental authority other than a branch of the federal 1-32 1-33 government, when being operated by or for the transportation of:
