- Sec. 8342.005. FINDINGS OF PUBLIC PURPOSE AND BENEFIT. (a)
- 21 The district is created to serve a public purpose and benefit.
- 22 (b) The district is created to accomplish the purposes of:
- 23 (1) a municipal utility district as provided by
- 24 general law and Section 59, Article XVI, Texas Constitution; and
- 25 (2) Section 52, Article III, Texas Constitution, that
- 26 relate to the construction, acquisition, improvement, operation,
- 27 or maintenance of macadamized, graveled, or paved roads, or

improvements, including storm drainage, in aid of those roads. 1 2 Sec. 8342.006. INITIAL DISTRICT TERRITORY. (a) The district is initially composed of the territory described by 3 Section 2 of the Act creating this chapter. 4 (b) The boundaries and field notes contained in Section 2 of 5 the Act creating this chapter form a closure. A mistake made in the 6 7 field notes or in copying the field notes in the legislative process 8 does not affect the district's: (1) organization, existence, or validity; 9 10 (2) right to issue any type of bond for the purposes for which the district is created or to pay the principal of and 11 12 interest on a bond; (3) right to impose a tax; or 13 14 (4) legality or operation. 15 [Sections 8342.007-8342.050 reserved for expansion] 16 SUBCHAPTER B. TEMPORARY DIRECTORS. (a) The temporary board consists of: 22 (1) <u>Jeffrey Krueger;</u> 23 24 (2) William Bruce Schneider; (3) Kevin Patton; 25 26 (4) Virgil R. Briscoe; and 27 (5) Jeffrey K. Wilson.

- 1 (b) Temporary directors serve until the earlier of:
- 2 (1) the date permanent directors are elected under
- 3 Section 8342.003; or
- 4 (2) September 1, 2013.
- 5 (c) If permanent directors have not been elected under
- 6 Section 8342.003 and the terms of the temporary directors have
- 7 expired, successor temporary directors shall be appointed or
- 8 reappointed as provided by Subsection (d) to serve terms that
- 9 expire on the earlier of:
- 10 (1) the date permanent directors are elected under
- 11 Section 8342.003; or
- 12 (2) the fourth anniversary of the date of the
- 13 appointment or reappointment.
- 14 (d) If Subsection (c) applies, the owner or owners of a

- 11 project must meet all applicable construction standards, zoning and

- 27 applicable regulations of any municipality in whose corporate

- 10 district may not exercise the power of eminent domain outside the
- 11 district to acquire a site or easement for:
- 12 (1) a road project authorized by Section 8342.103; or
- 13 (2) a recreational facility as defined by Section
- 14 49.462, Water Code.
- Sec. 8342.108. DIVISION OF DISTRICT. (a) The district may
- 16 be divided into two or more new districts only if the district:
- 17 (1) has no outstanding bonded debt; and
- 18 (2) is not imposing ad valorem taxes.

- 10 (2) the majority owner of the assessed value of the
- 11 real property in the district or the new district, as applicable;
- 12 and
- 13 (3) the governing body of each municipality in whose

- 16 (b) The district or any new district may not be dissolved if
