1 AN ACT

- 2 relating to the transfer of certain state property from the
- 3 Department of Aging and Disability Services to certain community
- 4 mental health and mental retardation centers.
- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. (a) The Department of Aging and Disability
- 7 Services may transfer to community centers described by Section
- 8 534.001(b)(3), Health and Safety Code, and as specifically
- 9 designated in Section 2 of this Act, all or part of the real
- 10 property as specified in Section 2 of this Act:
- 11 (1) including improvements to the property; and
- 12 (2) excluding the mineral interests in and under the
- 13 property.
- 14 (b) Consideration for the transfers authorized by
- 15 Subsection (a) of this section shall be in the form of an agreement
- 16 between the Department of Aging and Disability Services and each
- 17 community center that requires the community center to use the
- 18 property in a manner that primarily promotes a public purpose of the
- 19 state by using the property to provide community-based mental
- 20 health or mental retardation services.
- 21 (c) If a community center fails to use the property in the
- 22 manner described by an agreement under Subsection (b) of this
- 23 section for more than 180 continuous days, ownership of the
- 24 property automatically reverts to the Department of Aging and

- 1 Disability Services.
- 2 (d) The Department of Aging and Disability Services shall
- 3 transfer each property by a deed that:
- 4 (1) is without warranties regarding covenants of
- 5 title; and
- 6 (2) includes a provision that:
- 7 (A) requires the community center to use the
- 8 property in a manner that primarily promotes a public purpose of the
- 9 state by using the property to provide community-based mental
- 10 health and mental retardation services; and
- 11 (B) indicates that ownership of the property
- 12 automatically reverts to the Department of Aging and Disability
- 13 Services if the community center fails to use the property as
- 14 described by Subsection (b) of this section for more than 180
- 15 continuous days.
- 16 (e) The state reserves:
- 17 (1) the state's interest in all oil, gas, and other
- 18 minerals in and under the real property described by Section 2 of
- 19 this Act;
- 20 (2) the state's right to remove from the real property
- 21 described by Section 2 of this Act any oil, gas, and other minerals
- 22 in and under the real property; and
- 23 (3) the state's right to grant a lease held by the
- 24 state before a conveyance of real property described by Section 2 of
- 25 this Act relating to the removal of oil, gas, and other minerals in
- 26 and under the real property.
- 27 (f) Sections 533.084 and 533.087, Health and Safety Code,

- 1 and Sections 31.1571 and 31.158, Natural Resources Code, do not
- 2 apply to a transfer of real property authorized by this Act.
- 3 SECTION 2. The Department of Aging and Disability Services
- 4 shall transfer to:

- 5 Act takes effect September 1, 2009.
