2 (c) The commission may issue a professional achievement or
3 proficiency certificate to an officer, county jailer, or justice of
4 the peace who meets the requirements of Subsection (b).

5 SECTION 2. (a) The Commission on Law Enforcement Officer Standards and Education may certify a county jailer as a special 6 officer for offenders with mental impairments and may issue a 7 8 certificate to the county jailer if the county jailer meets the requirements of Section 1701.404(b), Occupations Code, as amended 9 10 by this Act, regardless of whether the county jailer completed the required training and passed the examination before, on, or after 11 the effective date of this Act. 12

(b) The Commission on Law Enforcement Officer Standards and Education may issue a certificate under Section 1701.404(c), Occupations Code, as amended by this Act, to a justice of the peace who is certified as a special officer for offenders with mental impairments regardless of whether the justice of the peace was certified before, on, or after the effective date of this Act.

19 SECTION 3. This Act takes effect September 1, 2009.
