10	Sec. 8330.001. DEFINITIONS. In this chapter:
11	(1) "Board" means the district's board of directors.
12	(2) "Director" means a board member.
13	(3) "District" means the Fort Bend County Municipal
14	Utility District No. 192.
15	Sec. 8330.002. NATURE OF DISTRICT. The district is a
16	municipal utility district created under Section 59, Article XVI,
17	Texas Constitution.

Sec. 8330.003. CONFIRMATION AND DIRECTORS' ELECTION

- 19 REQUIRED. The temporary directors shall hold an election to
- confirm the creation of the district and to elect five permanent 20
- 21 directors as provided by Section 49.102, Water Code.
- Sec. 8330.004. CONSENT OF MUNICIPALITY REQUIRED. (a) The 22
- temporary directors may not hold an election under Section 8330.003 23
- 24 until each municipality in whose corporate limits or

- 17 The district is created to serve a public purpose and benefit.

- 20 general law and Section 59, Article XVI, Texas Constitution; and
- 21 (2) Section 52, Article III, Texas Constitution, that
- 22 relate to the construction, acquisition, or improvement of
- 23 macadamized, graveled, or paved roads described by Section 54.234,
- 24 Water Code, or improvements, including storm drainage, in aid of
- 25 those roads.
- Sec. 8330.006. INITIAL DISTRICT TERRITORY. (a) The
- 27 district is initially composed of the territory described by

1 Section 2 of the Act creating this chapter. 2 (b) The boundaries and field notes contained in Section 2 of 3 the Act creating this chapter form a closure. A mistake made in the field notes or in copying the field notes in the legislative process 4 5 does not affect the district's: 6 (1) organization, existence, or validity; 7 (2) right to issue any type of bond for the purposes for which the district is created or to pay the principal of and 8 interest on a bond; 9 10 (3) right to impose a tax; or (4) <u>legality or operation.</u> 11 12 [Sections 8330.007-8330.050 reserved for expansion] SUBCHAPTER B. BOARD OF DIRECTORS 13 Sec. 8330.051. GOVERNING BODY; TERMS. - SUBCHAPTER C. POWERS AND DUTIES
- Sec. 8330.101. GENERAL POWERS AND DUTIES. The district has
- 23 the powers and duties necessary to accomplish the purposes for
- 24 which the district is created.
- Sec. 8330.102. MUNICIPAL UTILITY DISTRICT POWERS AND
- 26 DUTIES. The district has the powers and duties provided by the
- 27 general law of this state, including Chapters 49 and 54, Water Code,

- 1 applicable to municipal utility districts created under Section 59,
- 2 Article XVI, Texas Constitution.
- 3 Sec. 8330.103. AUTHORITY FOR ROAD PROJECTS. (a) Under
- 4 Section 52, Article III, Texas Constitution, the district may

- 6 convey to this state, a county, or a municipality for operation and
- 7 maintenance macadamized, graveled, or paved roads described by

- 19 road project, if a municipality or county will operate and maintain
- 20 the road; or

- 23 operate and maintain the road.
- 24 (b) Except as provided by Subsection (a), the district is
- 25 <u>not required to obtain approval from the Texas Transportation</u>

- 1 Sec. 8330.105. LIMITATION ON USE OF EMINENT DOMAIN. The
- 2 district may not exercise the power of eminent domain outside the
- 3 district to acquire a site or easement for:
- 4 (1) a road project authorized by Section 8330.103; or
- 5 (2) a recreational facility as defined by Section
- 6 49.462, Water Code.
- 7 [Sections 8330.106-8330.150 reserved for expansion]
- 8 <u>SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS</u>
- 9 Sec. 8330.151. ELECTIONS REGARDING TAXES OR BONDS. (a) The
- 10 district may issue, without an election, bonds and other
- 11 obligations secured by:
- 12 (1) revenue other than ad valorem taxes; or
- 13 (2) contract payments described by Section 8330.153.
- 14 (b) The district must hold an election in the manner
- 15 provided by Chapters 49 and 54, Water Code, to obtain voter approval

- 26 (b) The board shall determine the tax rate. The rate may not
- 27 exceed the rate approved at the election.

- 1 Sec. 8330.153. CONTRACT TAXES. (a) In accordance with
- 2 Section 49.108, Water Code, the district may impose a tax other than
- 3 an operation and maintenance tax and use the revenue derived from
- 4 the tax to make payments under a contract after the provisions of
- 5 the contract have been approved by a majority of the district voters
- 6 voting at an election held for that purpose.
- 7 (b) A contract approved by the district voters may contain a
- 8 provision stating that the contract may be modified or amended by
- 9 the board without further voter approval.

- SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS
- 12 Sec. 8330.201. AUTHORITY TO ISSUE BONDS AND OTHER
- 13 OBLIGATIONS. The district may issue bonds or other obligations
- 14 payable wholly or partly from ad valorem taxes, impact fees,
- 15 revenue, contract payments, grants, or other district money, or any
- 16 combination of those sources, to pay for any authorized district
- 17 purpose.
- 18 Sec. 8330.202. TAXES FOR BONDS. At the time the district
- 19 issues bonds payable wholly or partly from ad valorem taxes, the
- 20 board shall provide for the annual imposition of a continuing
- 21 direct ad valorem tax, without limit as to rate or amount, while all
- 22 or part of the bonds are outstanding as required and in the manner
- 23 provided by Sections 54.601 and 54.602, Water Code.
- Sec. 8330.203. BONDS FOR ROAD PROJECTS. At the time of
- 25 issuance, the total principal amount of bonds or other obligations
- 26 issued or incurred to finance road projects and payable from ad
- 27 valorem taxes may not exceed one-fourth of the assessed value of the

1 real property in the district.
