5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subchapter C, Chapter 61, Education Code, is
7	amended by adding Section 61.0885 to read as follows:
8	Sec. 61.0885. UNIFORM FINANCIAL AID NOTIFICATION. (a) The
9	board by rule shall:
10	(1) require each institution of higher education to
11	notify any student or prospective student regarding the
12	institution's financial aid award offered to the student for
13	attendance at the institution; and
14	(2) prescribe a common financial aid notification form
15	to be used for that notice regardless of whether the notice is
16	delivered to the student by mail or electronically.
17	(b) A notice provided using the common financial aid
18	notification form prescribed by the board under this section must:
19	(1) be suitable for printing, whether delivered by
20	mail or electronically; and
21	(2) include, in a clear, concise, and uniform manner,
22	the following information:
23	(A) an itemized list of all financial aid offered
24	to the student for attendance at the institution, including any

1	financial aid offered by any department, school, or office of the
2	institution, separated according to the following four categories:
3	(i) gift aid, including grants,
4	scholarships, and tuition exemptions or waivers;
5	(ii) student loans;
6	(iii) work-study opportunities; and
7	(iv) any other form of financial aid
8	available to the student;
9	(B) the institution's reasonable estimation of
10	the total amount of tuition and fees to be charged to the student
11	for attendance at the institution and a comparison of that
12	estimated amount to the total amount of gift aid available to the
13	student under Paragraph (A)(i);
14	(C) the institution's reasonable estimation of
15	the student's:
16	(i) total cost of full-time attendance at
17	the institution, including tuition and fees, room and board costs,
18	book and supply costs, transportation costs, and other personal
19	expenses;
20	(ii) expected family contribution; and
21	(iii) net financial need; and
22	(D) a clear explanation of the institution's
23	policies and timelines for accepting or declining the financial aid
24	award.
25	(c) A private or independent institution of higher
26	education may use the common financial aid notification form
27	prescribed by the board under this section to notify students and

1 prospective students regarding the institution's financial aid 2 award offered to a student for attendance at the institution.

3 <u>(d) An institution of higher education may but is not</u> 4 <u>required to use the common financial aid award notification form</u> 5 <u>prescribed by the board under this section for the notification of</u> 6 <u>financial aid awards for an academic year before the 2011-2012</u> 7 <u>academic year. This subsection expires September 1, 2011.</u>

8 SECTION 2. The Texas Higher Education Coordinating Board 9 shall adopt the rules required by Section 61.0885, Education Code, 10 as added by this Act, as soon as practicable after this Act takes 11 effect. For that purpose, the coordinating board may adopt the 12 initial rules in the manner provided by law for emergency rules.

13 SECTION 3. This Act takes effect immediately if it receives 14 a vote of two-thirds of all the members elected to each house, as 15 provided by Section 39, Article III, Texas Constitution. If this 16 Act does not receive the vote necessary for immediate effect, this 17 Act takes effect September 1, 2009.
