## A BILL TO BE ENTITLED

- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 SECTION 1. The heading to Section 54.211, Education Code,
- 8 is amended to read as follows:
- 9 Sec. 54.211. EXEMPTIONS FOR STUDENTS UNDER CONSERVATORSHIP
- 10 OF DEPARTMENT OF FAMILY AND PROTECTIVE SERVICES [IN FOSTER OR OTHER
- 11 RESIDENTIAL CARE].
- 12 SECTION 2. Section 54.211(a), Education Code, is amended to
- 13 read as follows:
- 14 (a) A student is exempt from the payment of tuition and fees
- 15 authorized in this chapter if the student:
- 16 (1) was [in foster care or other residential care]
- 17 under the conservatorship of the Department of Family and
- 18 Protective Services [on or after]:
- 19 (A) on the day preceding the student's 18th
- 20 birthday;
- 21 (B) on or after the day of the student's 14th
- 22 birthday, if the student was also eligible for adoption on or after
- 23 that day; [or]
- (C) on the day the student graduated from high

- 1 school or received the equivalent of a high school diploma; or
- 2 (D) during an academic term in which the student
- 3 was enrolled in a dual credit course or other course for which a
- 4 high school student may earn joint high school and college credit;
- 5 and
- 6 (2) enrolls in an institution of higher education as
- 7 an undergraduate student or in a dual credit course or other course
- 8 for which a high school student may earn joint high school and
- 9 college credit not later than:
- 10 (A) the third anniversary of the date the student
- 11 was discharged from the conservatorship of the Department of Family
- 12 and Protective Services [foster or other residential care], the
- 13 date the student graduated from high school, or the date the student
- 14 received the equivalent of a high school diploma, whichever date is
- 15 earliest; or
- 16 (B) the student's <u>25th</u> [<del>21st</del>] birthday.
- 17 SECTION 3. Section 54.211, Education Code, as amended by
- 18 this Act, applies beginning with tuition and other fees charged for
- 19 the 2009 fall semester. Tuition and other fees charged for an
- 20 academic period before that semester are covered by the law in
- 21 effect immediately before the effective date of this Act, and the
- 22 former law is continued in effect for that purpose.
- 23 SECTION 4. This Act takes effect immediately if it receives
- 24 a vote of two-thirds of all the members elected to each house, as
- 25 provided by Section 39, Article III, Texas Constitution. If this
- 26 Act does not receive the vote necessary for immediate effect, this
- 27 Act takes effect September 1, 2009.
