- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Section 2, Chapter 1362, Acts of the 77th
- 5 Legislature, Regular Session, 2001, is amended to read as follows:
- 6 Sec. 2. DEFINITIONS [DEFINITION]. In this Act:
- 7 (1) "Board" means the district's board of directors.
- 8 (2) "Director" means a board member.
- 9 <u>(3) "District"</u>[, "district"] means the Middle Trinity
- 10 Groundwater Conservation District.
- 11 SECTION 2. Section 6, Chapter 1362, Acts of the 77th
- 12 Legislature, Regular Session, 2001, is amended by amending
- 13 Subsection (a) and adding Subsection (g) to read as follows:
- 14 (a) Except as provided by Sections [Section] 10, 11A, and
- 15 11B of this Act, the district is governed by a board of six
- 16 directors.
- 17 (g) Section 36.051(a), Water Code, does not apply to the
- 18 <u>district.</u>
- 19 SECTION 3. Section 9, Chapter 1362, Acts of the 77th
- 20 Legislature, Regular Session, 2001, is amended by amending
- 21 Subsection (a) and adding Subsection (c) to read as follows:
- 22 (a) Except as provided by Subsection (c) of this section and
- 23 Sections [Section] 10 and 11B of this Act, three directors shall be
- 24 elected from each county in the district.

- 1 (c) The board by resolution may change the number of
- 2 directors elected from a county in the district for the purpose of
- 3 equalizing representation of the residents of the district.
- 4 SECTION 4. Section 11(b), Chapter 1362, Acts of the 77th
- 5 Legislature, Regular Session, 2001, is amended to read as follows:
- 6 (b) Except as provided by Sections 11A and 11B of this Act,
- 7 on $[\frac{\Theta n}{T}]$ the uniform election date $[\frac{First Saturday}{T}]$ in May of each
- 8 even-numbered [subsequent second] year [following the election],
- 9 the appropriate number of directors shall be elected.
- SECTION 5. Chapter 1362, Acts of the 77th Legislature,
- 11 Regular Session, 2001, is amended by adding Section 11A to read as
- 12 follows:
- 13 Sec. 11A. COMPOSITION OF BOARD AND ELECTION OF DIRECTORS
- 14 FOLLOWING ANNEXATION OF ONE OR TWO COUNTIES. (a) This section
- 15 applies only following the annexation by the district under
- 16 Subchapter J, Chapter 36, Water Code, after January 1, 2009, of the
- 17 territory of one or two additional counties.
- 18 (b) Not later than the 90th day after the date of an election
- 19 in which the annexation of a county to the district is ratified by a
- 20 majority vote of the voters of that county, the commissioners court
- 21 of the annexed county shall appoint three temporary directors to
- 22 the board. Temporary directors serve until initial permanent
- 23 <u>directors are elected under Subsection (c).</u>
- 24 <u>(c) Initial permanent directors shall be elected from a</u>
- 25 county that is annexed by the district on the uniform election date
- 26 in May of the first odd-numbered year following the election in
- 27 which annexation of that county is ratified. The initial permanent

- 1 directors from the county shall draw lots to determine who will
- 2 serve a four-year term and who will serve a two-year term.
- 3 (d) On the uniform election date in May of each odd-numbered
- 4 year following the election of initial permanent directors under
- 5 Subsection (c), the appropriate number of directors from a county
- 6 that is annexed by the district shall be elected.
- 7 SECTION 6. Chapter 1362, Acts of the 77th Legislature,
- 8 Regular Session, 2001, is amended by adding Section 11B to read as
- 9 follows:
- 10 Sec. 11B. COMPOSITION OF BOARD AND ELECTION OF DIRECTORS
- 11 FOLLOWING ANNEXATION OF MORE THAN TWO COUNTIES. (a) This section
- 12 applies only following the annexation by the district under
- 13 Subchapter J, Chapter 36, Water Code, after January 1, 2009, of the
- 14 territory of a third additional county or the simultaneous or
- 15 subsequent annexation of the territory of other additional
- 16 counties.
- 17 <u>(b) After annexation, two directors shall be elected from</u>
- 18 each county in the district as provided by this section.
- 19 (c) Not later than the 90th day after the date of an election
- 20 in which the annexation of a county is ratified by a majority vote
- 21 of the voters of that county, the commissioners court of each
- 22 annexed county shall appoint two temporary directors to the board.
- 23 Temporary directors serve until initial permanent directors are
- 24 elected under Subsection (d).
- 25 (d) Initial permanent directors shall be elected from any
- 26 county that is annexed by the district on the uniform election date
- 27 in May of the first odd-numbered year following the election in

- 1 which annexation of that county is ratified. The initial permanent
- 2 directors from the county shall draw lots to determine who will
- 3 serve a four-year term and who will serve a two-year term.
- 4 (e) On the date of the next regularly scheduled directors'
- 5 election in an even-numbered year following the election in which
- 6 <u>annexation of a county is ratified:</u>
- 7 (1) one director position from Comanche County and one
- 8 director position from Erath County are abolished; and
- 9 (2) the terms of the directors serving in those
- 10 positions expire on the date of the election.
- 11 (f) On the date of the next regularly scheduled directors'
- 12 election in an odd-numbered year following the election in which
- 13 annexation of the county is ratified:
- 14 (1) one director position from each of the first two
- 15 counties annexed by the district after January 1, 2009, is
- 16 abolished; and
- 17 (2) the terms of the directors serving in those
- 18 positions expire on the date of the election.
- 19 (g) If more than one position described by Subsection (e)(1)
- 20 or (f)(1) is scheduled for election in Comanche County, Erath
- 21 County, or one of the first two counties annexed by the district
- 22 after January 1, 2009, the directors of the county shall draw lots
- 23 to determine which position shall be abolished in accordance with
- 24 Subsections (e) and (f).
- 25 (h) On the uniform election date in May of each odd-numbered
- 26 year following the election of initial permanent directors under
- 27 Subsection (d), the appropriate number of directors from a county

- 1 that is annexed by the district shall be elected.
- 2 SECTION 7. Chapter 1362, Acts of the 77th Legislature,
- 3 Regular Session, 2001, is amended by adding Section 13 to read as
- 4 follows:
- 5 Sec. 13. DISTRICT RULES; ENFORCEMENT. (a) Any rules
- 6 adopted by the district as authorized by this Act and Chapter 36,
- 7 Water Code, apply to all persons and entities except as exempted
- 8 <u>under Section 36.117, Water Code.</u>
- 9 (b) The district may enforce its rules and the provisions of
- 10 Chapter 36, Water Code, in the manner authorized by Chapter 36,
- 11 Water Code. In addition to the remedies under Section 36.102, Water
- 12 Code, the district may impose a fee on a person or entity for
- 13 violation of a rule of the district or failure to comply with an
- 14 order issued by the district.
- 15 SECTION 8. (a) The legal notice of the intention to
- 16 introduce this Act, setting forth the general substance of this
- 17 Act, has been published as provided by law, and the notice and a
- 18 copy of this Act have been furnished to all persons, agencies,
- 19 officials, or entities to which they are required to be furnished
- 20 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 21 Government Code.
- 22 (b) The governor, one of the required recipients, has
- 23 submitted the notice and Act to the Texas Commission on
- 24 Environmental Quality.
- 25 (c) The Texas Commission on Environmental Quality has filed
- 26 its recommendations relating to this Act with the governor, the
- 27 lieutenant governor, and the speaker of the house of

- 1 representatives within the required time.
- 2 (d) All requirements of the constitution and laws of this
- 3 state and the rules and procedures of the legislature with respect
- 4 to the notice, introduction, and passage of this Act are fulfilled
- 5 and accomplished.
- 6 SECTION 9. This Act takes effect immediately if it receives
- 7 a vote of two-thirds of all the members elected to each house, as
- 8 provided by Section 39, Article III, Texas Constitution. If this
- 9 Act does not receive the vote necessary for immediate effect, this
- 10 Act takes effect September 1, 2009.
