5	SECTION 1. Section 4001.101, Insurance Code, is amended to

8	REQUIRED; DESIGNATED PRODUCT CERTIFICATE. (a) Unless the person
9	holds a license or certificate of authority issued by the
10	department and, if required by rules adopted under Chapter 4008, a
11	certificate to sell a designated product or product line, a person
12	may not:
13	(1) solicit or receive an application for insurance in
14	this state; or
15	(2) aid in the transaction of the business of an
16	insurer.
17	(b) A person may not act as an agent of a health maintenance
18	organization or other type of insurer authorized to engage in
19	business in this state unless the person holds <u>:</u>
20	(1) a license issued by the department as provided by
21	this title; and
22	(2) if required by rules adopted under Chapter 4008, a
23	certificate to sell a designated product or product line.
24	(c) An insurer described by Subsection (b) may not appoint a

person to act as its agent unless the person holds:
 <u>(1)</u> a license under this title; and

3 (2) if required by rules adopted under Chapter 4008, a
4 certificate to sell a designated product or product line.

(d) This subchapter does not permit an employee or agent of
a corporation or partnership to perform an act of an agent under
this title without obtaining:

(1) a license; and

9 (2) if required by rules adopted under Chapter 4008, a
 10 certificate to sell a designated product or product line.

SECTION 2. Section 4004.053(a), Insurance Code, is amended to read as follows:

An individual who holds a general life, accident, and 13 (a) 14 health license, a life agent license, a life and health insurance 15 counselor license, a general property and casualty license, or a personal lines property and casualty license must complete 15 hours 16 17 of continuing education annually. If the individual holds more than one license for which continuing education is otherwise 18 19 required, the individual is not required to complete more than 15 continuing education hours annually. An individual who is required 20 under rules adopted under Chapter 4008 to hold a certificate to sell 21 a designated product or product line may use continuing education 22 programs administered under Section 4004.151 to satisfy the annual 23 24 continuing education requirements under this subsection.

25 SECTION 3. Chapter 4004, Insurance Code, is amended by 26 adding Subchapter D to read as follows:

In addition to any other remedy available under Chapter 82, for a violation of this code, another insurance 17 law of this state, or a rule of the commissioner, the department 18 19 may: 20 deny an application for: (1) 21 (A) an original license; or (B) a certificate issued under Chapter 4008; 2.2 suspend, revoke, or deny renewal of : 23 (2) 24 (A) a license; or 25 (B) a certificate issued under Chapter 4008; 26 (3) place on probation a person whose license has been 27 suspended;

1 (4) assess an administrative penalty; [or] 2 reprimand a license holder; or (5) 3 (6) require a license holder to qualify, or re-qualify if the agent has already qualified, for a certificate to sell a 4 5 product or product line designated by rule under Chapter 4008. 6 SECTION 5. Subtitle A, Title 13, Insurance Code, is amended 7 by adding Chapter 4008 to read as follows: CHAPTER 4008. AGENT CERTIFICATION AND EDUCATION PROGRAMS FOR 8 COMPLEX INSURANCE PRODUCTS 9 10 Sec. 4008.001. PURPOSE. Certain insurance products are so complex that the general agent licensing and continuing education 11 12 requirements are insufficient to ensure the level of agent expertise necessary to safeguard consumer interests. Agents should 13 14 be equipped with the necessary skills and knowledge to assist 15 insureds appropriately in their purchases. Requiring agent training or demonstration of knowledge before an agent may sell 16 17 particularly complex products mitigates the negative impact caused by agents selling complex products without the training and 18 19 knowledge necessary to sell those products in a manner that is fair and beneficial to insureds. 20 21 Sec. 4008.002. TRAINING AND EXAMINATION REQUIREMENTS AUTHORIZED. (a) The commissioner may adopt rules requiring an 22 agent who holds a license issued under this code to be certified, 23 24 through specific education, training, examination, and experience requirements as provided by this chapter, before an agent may sell a 25 26 product or product line designated by the commissioner. 27 (b) Education, training, examination, and experience

1 requirements established by rule under this chapter may be used to 2 satisfy any other agent education, training, examination, and experience requirements otherwise established under this code. 3 4 Sec. 4008.003. RULES. (a) In adopting rules under this 5 chapter, the commissioner shall: 6 (1) designate the products or product lines that may 7 not be sold without certification under this chapter; and (2) specify the reasons why it is necessary that the 8 sale of a designated product or product line requires education, 9 10 experience, or examination. 11 (b) By rule, the commissioner may specify: 12 (1) any precertification education or experience that must be completed before a designated product or product line may be 13 14 sold by an agent; 15 (2) whether an agent must complete a precertification 16 examination concerning the designated product or product line the 17 agent intends to sell; (3) whether an agent certified under this chapter must 18 complete specific continuing education to maintain 19 the 20 certificate; and 21 (4) whether, and if so, how frequently, an agent certified under this chapter must periodically retake the 22 23 examination to maintain the certificate. 24 Sec. 4008.004. APPLICATION OF CERTIFICATION REQUIREMENTS TO CERTAIN AGENTS. (a) The commissioner by rule shall establish 25 26 whether the certification requirements established under this chapter for sale by an agent of a designated product or product line 27

11	Sec. 4008.005. ISSUANCE OF CERTIFICATE. The department
12	shall issue a certificate under this chapter to an agent if the
13	department determines that the agent:
14	(1) has submitted a properly completed certification
15	application to the department in a form acceptable to the
16	<pre>department;</pre>
17	(2) has completed, within the 12-month period
18	preceding the date of the certification application, all
19	requirements for the certification required by rules adopted under
20	this chapter; and
21	(3) has not committed an act for which a license or
22	certification may be denied under Subchapter C, Chapter 4005.
23	Sec. 4008.006. CERTIFICATE EXPIRATION. Unless the
24	commissioner by rule specifies a different period, each certificate
25	issued under this chapter expires on the expiration date of the
26	agent's appropriate underlying license.
27	Sec. 4008.007. CERTIFICATE RENEWAL. (a) An agent may renew

an unexpired certificate before the expiration of the certificate 1 2 by: 3 (1) completing all renewal requirements established 4 by rule under this chapter; and 5 (2) filing a properly completed renewal application 6 with the department in a form acceptable to the department. 7 (b) A person may not renew a certificate that has been 8 suspended or revoked. 9 Sec. 4008.008. ADMINISTRATION ΒY TESTING SERVICE The <u>commissioner may accept</u> an examination 10 AUTHORIZED. administered by a testing service, as provided under Subchapter B, 11 Chapter 4002, to satisfy an examination requirement required by 12 rule under this chapter. 13 SECTION 6. This Act takes effect immediately if it receives 14 15 a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this 16 17 Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2009. 18
