6	SECTION 1. Subchapter Z, Chapter 51, Education Code, is
7	amended by adding Section 51.974 to read as follows:
8	Sec. 51.974. INTERNET ACCESS TO COURSE INFORMATION. (a)
9	Each institution of higher education, as defined by Section 61.003,
10	shall make available to the public on the institution's Internet
11	website the following information for each undergraduate classroom
12	course offered for credit by the institution:
13	(1) a syllabus that:
14	(A) satisfies any standards adopted by the
15	<pre>institution;</pre>
16	(B) provides a brief description of each major
17	course requirement, including each major assignment and
18	<pre>examination;</pre>
19	(C) lists any required or recommended reading;
20	<u>and</u>
21	(D) provides a general description of the subject

(2) a curriculum vitae of each regular instructor that

1	(A) postsecondary education;
2	(B) teaching experience; and
3	(C) significant professional publications; and
4	(3) if available, a departmental budget report of the
5	department under which the course is offered, from the most recent
6	semester or other academic term during which the institution
7	offered the course.
8	(b) The information required by Subsection (a) must be:
9	(1) accessible from the institution's Internet website
10	home page by use of not more than three links;
11	(2) searchable by keywords and phrases; and
12	(3) accessible to the public without requiring
13	registration or use of a user name, a password, or another user
14	<pre>identification.</pre>
15	(c) The institution shall make the information required by
16	Subsection (a) available not later than the seventh day after the
17	first day of classes for the semester or other academic term during
18	which the course is offered. The institution shall continue to make
19	the information available on the institution's Internet website
20	until at least the fourth anniversary of the date on which the
21	institution initially posted the information.
22	(d) The institution shall update the information required
23	by Subsection (a) as soon as practicable after the information
24	changes.
25	(e) The governing body of the institution shall designate an
26	administrator to be responsible for ensuring implementation of this
27	section. The administrator may assign duties under this section to

- 1 one or more administrative employees.
- 2 (f) Not later than January 1 of each odd-numbered year, each
- 3 <u>institution of higher education shall submit a written report</u>
- 4 regarding the institution's compliance with this section to the
- 5 governor, the lieutenant governor, the speaker of the house of
- 6 representatives, and the presiding officer of each legislative
- 7 standing committee with primary jurisdiction over higher
- 8 education.
- 9 (g) The Texas Higher Education Coordinating Board may adopt
- 10 <u>rules necessary to administer this section.</u>
- 11 SECTION 2. Section 51.974, Education Code, as added by this
- 12 Act, applies beginning with the 2010 fall semester.
- 13 SECTION 3. This Act takes effect immediately if it receives
- 14 a vote of two-thirds of all the members elected to each house, as
- 15 provided by Section 39, Article III, Texas Constitution. If this
- 16 Act does not receive the vote necessary for immediate effect, this
- 17 Act takes effect September 1, 2009.
