(c) The district may not undertake a road project unless each municipality in whose corporate limits or extraterritorial jurisdiction the district is located consents by ordinance or resolution. If a district is located outside the extraterritorial jurisdiction of a municipality, the district may not undertake a road project unless each county in which the district is located

consents by ordinance or resolution.

- SECTION 3. (a) The legal notice of the intention to 11-63 introduce this Act, setting forth the general substance of this Act, has been published as provided by law, and the notice and a copy of this Act have been furnished to all persons, agencies, 11-64 11**-**65 11-66 officials, or entities to which they are required to be furnished 11-67 under Section 59, Article XVI, Texas Constitution, and Chapter 313, 11-68
