9	population of 50,000 or more.
10	(b) The commissioners court of a county shall maintain the
11	transaction register for the county's checking account in a
12	searchable electronic spreadsheet format, such as a portable
13	document format (PDF) or similar file type, in which the
14	transaction register is readily available for purposes of
15	Subsections (d) and (e). Except as provided by Subsection (c), the
16	electronic checking account transaction register must include for
17	each check written from a county checking account:

- (1) the transaction amount;
- 19 (2) the name of the payee; and
- (3) a statement of the purpose of the expenditure for 20

- (b-1) Notwithstanding Subsection (b), beginning September 22
- 23 1, 2009, a county's electronic checking account transaction

- 1 (b)(1) and (2) for each check dated on or after August 1, 2009.
- 2 Beginning September 1, 2010, a county's electronic checking account
- 3 transaction register must contain the information required by
- 4 Subsections (b)(1) through (3) for each check dated on or after
- 5 August 1, 2010. This subsection expires October 1, 2010.
- 6 (c) A county may not include in the county's electronic
- 7 checking account transaction register a check issued to a county

- 9 (1) salary, wages, or an employment stipend; or
- 10 (2) a workers' compensation income benefit, medical
- 11 benefit, death benefit, or burial benefit that is issued by a county

- 13 (d) A county shall prominently post the electronic checking

- 6 provided by Section 39, Article III, Texas Constitution. If this

- 8 Act takes effect September 1, 2009.
