A BILL TO BE ENTITLED 1 AN ACT 2 relating to the regulation of industrialized housing and buildings. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 1202.002(c), Occupations Code, 4 is 5 amended to read as follows: 6 (c) Industrialized housing does not include: 7 (1) a residential structure that exceeds three stories or 49 feet in height [as measured from the finished grade elevation 8 at the building entrance to the peak of the roof]; 9 (2) housing constructed of a sectional or panelized 10 11 system that does not use a modular component; or 12 (3) a ready-built home constructed in a manner in 13 which the entire living area is contained in a single unit or 14 section at a temporary location for the purpose of selling and moving the home to another location. 15 SECTION 2. Section 1202.003(d), Occupations 16 Code, is amended to read as follows: 17 18 (d) An industrialized building includes a permanent commercial structure and a commercial structure designed to be 19 20 transported from one commercial site to another commercial site but 21 does not include: 22 (1) a commercial structure that exceeds three stories 23 or 49 feet in height [as measured from the finished grade elevation at the building entrance to the peak of the roof]; or 24

No. 2763 1 (2) a commercial building or structure that is: 2 (A) installed in a manner other than on а 3 permanent foundation; and 4 (B) either: 5 (i) not open to the public; or 6 (ii) less than 1,500 square feet in total 7 area and used other than as a school or a place of religious 8 worship. 9 SECTION 3. Subchapter A, Chapter 1202, Occupations Code, is amended by adding Section 1202.004 to read as follows: 10 Sec. 1202.004. RELOCATABLE EDUCATIONAL FACILITIES. (a) In 11 this section, "relocatable educational facility" means a portable, 12 modular building capable of being relocated, regardless of whether 13 14 the facility is built at the installation site, that is used 15 primarily as an educational facility for teaching the curriculum required under Section 28.002, Education Code. 16 17 (b) A relocatable educational facility that is purchased or leased on or after January 1, 2010, must comply with all provisions 18 19 applicable to industrialized buildings under this chapter. SECTION 4. Section 1202.1535(b), Occupations Code, 20 is amended to read as follows: 21 The owner of an industrialized building designed to be 22 (b) transported from one commercial site to another that bears an 23 24 approved decal or insignia indicating the building complies with the mandatory building codes and that is modified or altered after 25 26 the date the council adopts a new mandatory building code or the council approves a building code amendment must ensure that the 27

modified or altered building complies with the requirements and 1 standards of the new building code or amendment to the extent 2 required by the most recent edition of the International Existing 3 4 Building Code adopted by the council [+ [(1) the entire building complies with the mandatory 5 6 building code or building code amendment if the cost of the modification or alteration to the building is at least 50 percent of 7 8 the value of the modules or modular components used in the 9 construction of the building; or [(2) the modified or altered portion of the building 10 complies with the mandatory building code or building code 11 amendment if the cost of the modification or alteration is less than 12 50 percent of the value of the modules or modular components]. 13 SECTION 5. Section 46.008(b), Education Code, is repealed. 14 15 SECTION 6. This Act takes effect September 1, 2009.
