8	Sec. 109.001. DEFINITIONS. In this chapter:
9	(1) "Pay-to-park service" means a business that
10	provides a place to park the motor vehicles of patrons of a public
11	accommodation in a garage, lot, or other facility for a fee.
12	(2) "Valet parking service" means a parking service
13	through which the motor vehicles of patrons of a public
14	accommodation are parked for a fee by a third party who is not an
15	employee of the public accommodation.
16	(3) "Owner" means a person who owns the pay-to-park or
17	valet parking service. The term does not include the owner of the
18	property on which the pay-to-park or valet parking service is
19	provided unless the service is also owned by the owner of the

- (A) inn, hotel, or motel;
- (B) restaurant, cafeteria, or other facility

- 8 Sec. 109.002. REQUIREMENT OF CONTACT INFORMATION. (a) The
- 9 receipt or claim ticket that an operator of a pay-to-park or valet
- 10 parking service provides to a patron must state the owner's name,
- 11 address, and telephone number.
- 12 (b) If a pay-to-park service does not provide a patron with
- 13 a receipt or claim ticket, the operator shall prominently display
- 14 the owner's name, address, and telephone number on a sign on or
- 15 immediately adjacent to the payment receptacle or other device for

- 17 Sec. 109.003. CIVIL PENALTY. A pay-to-park or valet
- 18 parking service that violates this chapter is subject to a civil
- 19 penalty not to exceed \$200 for each violation.
- Sec. 109.004. SUIT FOR CIVIL PENALTY. The attorney general
- 21 or a county or district attorney may bring an action to recover a
- 22 <u>civil penalty imposed under Section 109.003.</u>
